1. Consolidated Financial Results not submitted - 1 Subsidiary and 1 Associate and two controlled entities financials are not included in CFS

Response:

Given below is the Company wise reason for not consolidating the Financials: (In question, they have asked queries for 4 companies but we are mentioning 5 companies. Please check before submitting)

OGD Services Limited (OGDSL)	OGDSL was admitted to Corporate Insolvency Resolution Process (CIRP) during the FY 2022-23. As a result, the board of the Company got dissolved and control vested with the Resolution Professional. The financial statements of OGDSL were therefore not available and were not considered for consolidation since then. Further, based on an application by the CoC, liquidation proceedings have been initiated in the case of OGDSL. The tribunal allowed the initiation of liquidation proceedings and an order dated April 29, 2024 bearing DIN IA-26/2024 IN CP(IB)-17(MB)/2019 was passed to liquidate the Company.
Seros Drilling Pvt Ltd (Seros)	OGDSL holds 26% share in Seros Drilling Pvt Ltd. Since OGDSL holds only 26%, the investment is accounted as per Equity Method and not considered for line by line consolidation. Since OGDSL itself was not consolidated, for reasons mentioned above, the investment made by them was also not considered for consolidation.

Starbit Oilfield Services India Limited (SOSIL)	OGDSL holds 26% share in Starbit Oilfield Services India Limited. Since OGDSL holds only 26%, the investment is accounted as per Equity Method and not considered for line by line consolidation. Since OGDSL itself was not consolidated, for reasons mentioned above, the investment made by them was also not considered for consolidation.
Drillxplore Services Pvt Ltd (Drillx)	Drillxplore Services Pvt. Ltd. was incorporated on 7 th June'2023. The financials of Drillxplore Services Pvt Ltd for the period starting from date of incorporation to 31 st March 2024 got finalised on 15-11-2024. As a result, the financial results for the quarter and half year ended 30 th September 2024 were not available. Hence, we have not considered the same for consolidation purpose.
Gargnano, S.A de C.V Mexico (Gargnano)	Gargnano, S.A de C.V Mexico is a foreign sub-subsidiary of the Company. The shares were acquired by Essar Shipping DMCC, Dubai on 7 th March'2024 and other than that no activity happened in the said foreign subsidiary. Further, the foreign subsidiary follows calendar year for accounting. In the absence of any transactions, we did not consider the said foreign subsidiary for consolidation.
