राज्य में ध्वस्त पड़ी कानून-व्यवस्था को सुदृढ़ एवं पब-बार पर प्रभावी नियंत्रण लगाया जाए

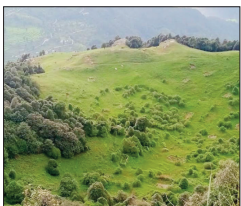

उसनतोली बुग्याल: क्रॉच पर्वत की गोद में प्रकृति, आस्था और संभावनाओं का अद्भुत संगम
