सीएम ने दिए पुल निर्माण कार्य निर्धारित समयसीमा के भीतर पूर्ण करने के निर्देश

देहरादून, (बी.ओ.) मुख्यमंत्री पुष्कर सिंह धामी ने मंगलवार को मसूरी रोड स्थित शिव मंदिर के निर्माणगोष्ठ पुल का स्थलगत निरीक्षण किया। निरीक्षण के दौरान उन्होंने बारिश से क्षतिग्रस्त हुए पुल को कार्य प्रगति की जानकारी ली। निरीक्षण के दौरान मुख्यमंत्री ने लोक निर्माण विभाग के अधिकारियों को निर्देश दिए कि पुल निर्माण का कार्य निर्धारित समयसीमा के भीतर पूर्ण किया जाए, ताकि आमजन को आवागमन में सुविधा मिल सके।



मुख्यमंत्री ने कहा कि यह पुल देहरादून और मसूरी को जोड़ने वाला एक अत्यंत महत्वपूर्ण संकेत मार्ग है, जिस पर प्रतिदिन बड़ी संख्या में स्थानीय नागरिकों एवं पर्यटकों का आवागमन होता है। उन्होंने कहा कि यातायात को सुचारू बनाए रखने के उद्देश्य से दोनों ओर से आवागमन के लिए वैकल्पिक को निर्माण कार्य शुरू किया जा रहा है, जो दूसरी ओर से भी शीघ्र ही पूर्ण होकर संचालित हो जाएगा।

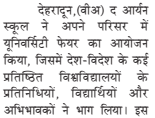

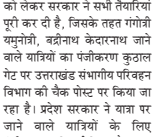
