**GIST OF PROCEEDINGS OF THE 5TH AGM OF EXCELLENT WIRES AND PACKAGING LIMITED
(FORMERLY KNOWN AS EXCELLENT WIRES AND PACKAGING PRIVATE LIMITED)****1. Date, time and Venue of the Meeting:**

The 5th Annual General Meeting of the Company was held on Wednesday, the 23rd September, 2026 and the meeting commenced at 09:00 a.m. (IST) through Video Conferencing / Other Audio-Visual Means (OAVM). The meeting was concluded at 09:11 a.m. (IST).

2. Brief details of items deliberated at the Meeting and result thereof:

- Mrs. Meghna Gala, Company Secretary and Compliance officer welcomed the Members to the Meeting and briefed them on details relating to their participation at the Meeting through Video Conferencing / Other Audio-Visual Means.
- Since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, Members were informed that the requirement of appointing proxies was not applicable.
- Mr. Bhavya Shah, chaired the proceedings of the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman then delivered his speech.
- Then Mr. Darshil Shah, CEO & Director and Mr. Rachit Masalia, Managing Director of the company addressed the members.
- The Members were informed that remote e-voting commenced at 9:00 a.m. on Sunday, 20th September, 2026 and ended at 5:00 p.m. on Tuesday, 22nd September, 2026. The Company Secretary informed the members that the facility for voting through e-voting system was made available for Members who had not cast their vote prior to the Meeting and this e-voting facility will be closed after 15 minutes from conclusion of the AGM.
- The Company Secretary thereafter took up the Ordinary and Special business items as set out in the notice convening the AGM for members' consideration and approval, as under:

Ordinary Business:

1. To consider and adopt the Standalone and Consolidated Financial Statements of the Company for the financial year ended March 31, 2026 and reports of the Board of Directors and Auditors thereon.

2. To appoint director in place of Mr. Darshil Shah (DIN: 09108019), the Director of the company who is liable to retire by rotation and, being eligible, offers himself for re-appointment pursuant to the provisions of Section 152 of the Companies Act, 2013.
 3. To appoint M/s. Suthar Parab & Co., Chartered Accountants, as a Statutory Auditors of the Company to fill casual vacancy.
- Members were informed that there were no qualification in the Statutory Auditors Report on the financial statements and Secretarial Auditors Report for the year ended 31st March, 2026.
 - There were no members who have registered themselves as speakers. The Members were informed that Mr. Jenish Doshi, Practicing Company Secretary was appointed as the scrutinizer for the purpose of scrutinizing the remote e-voting process and e-voting facility provided during the Annual General Meeting.
 - The Members were informed that the results declared along with the Scrutinizer's Report shall be placed on the Company's website at www.excellentwiresandpackaging.com and on the website of NSDL <https://www.evoting.nsdl.com> and will also be submitted to the NSE Limited at www.nseindia.com, within a period of two working days from the conclusion of the AGM as per the requirements under the SEBI Listing Regulations.

3. Manner of approval

- Pursuant to the provisions of the Companies Act, 2013 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations"), the Company had provided remote e-voting facility to its members to cast votes electronically, on all the resolutions set out in the notice.
- Further, the facility for electronic voting was made available to the members who were present at the Meeting and had not cast their votes by remote e-voting.
