Independent Auditors' Review Report on the Unaudited Financial Results for the quarter ended 30th June, 2026 of The Fertilisers and Chemicals Travancore Limited pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

To the Board of Directors of The Fertilisers and Chemicals Travancore Limited

1. We have reviewed the accompanying statement of unaudited financial results of **The Fertilisers and Chemicals Travancore Limited** ("the company") for the quarter ended 30th June, 2026 ("the Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
2. This statement, which is the responsibility of the Company's management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, ('Ind AS 34') "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an Audit. Accordingly, we do not express an audit opinion.
4. Based on our review conducted and procedures performed as stated above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standards specified under Section 133 of the Companies Act, 2013, as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India, has not disclosed the information required to



be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement.

Emphasis of Matter

We draw attention to Note No. 4 of the unaudited financial results for the quarter ended 30th June, 2026 regarding temporary shut down of certain manufacturing plants of the Company due to disruptions arising from the ongoing geopolitical situation in West Asia affecting the availability of key raw materials.

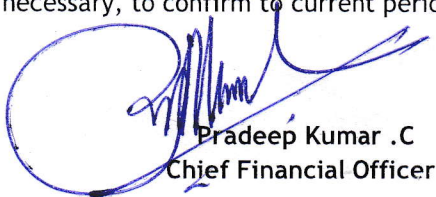

**UNAUDITED FINANCIAL RESULTS SHOWING SEGMENT WISE REVENUE, RESULTS & CAPITAL EMPLOYED
FOR THE QUARTER ENDED 30th JUNE 2026**

Notes:

1. These results have been approved by the Board of Directors in the meeting held on 14th August, 2026.
2. Auditors have given an unmodified opinion on the financial results of the Company for the quarter ended 30th June, 2026.
3. Subsidy portion of the stock with dealers, pending sale to ultimate beneficiary as on 30th June, 2026 is recognized on 100% recoverability basis.
4. Subsequent to the end of the reporting period, certain manufacturing plants of the Company are temporarily shut down due to disruptions arising from the ongoing geopolitical situation in West Asia affecting the availability of key raw materials.
5. Discontinuation of Consolidation of Financial Statements of FACT - RCF Building Products Limited (FRBL): The company had fully provided for the value of investment in FRBL in earlier years, owing to the share of losses in FRBL exceeding its interest. Further the Company had discontinued recognising its share of losses in FRBL in accordance with para 38 of Ind AS 28. National Company Law Tribunal (NCLT), Kochi Bench, vide its order dated 26.09.2025 approved a Resolution Plan. Pursuant to the approval of resolution plan, the Company has ceased to have joint control over FRBL. Accordingly, in line with the requirements of Ind AS 111 - Joint Arrangements and Ind AS 28 - Investments in Associates and Joint Ventures, the Company has discontinued consolidation of its interest in FRBL from the financial year 2025-26. The Company has filed an appeal against this NCLT order approving the Resolution Plan and the matter is currently pending adjudication before the National Company Law Appellate Tribunal (NCLAT), Chennai.
6. The above financial results of the Company have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations.
7. The above results have been reviewed by Audit Committee in their meeting and limited review of the same have been carried out by statutory auditors of the Company as required under Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
8. The figures for the corresponding previous periods have been regrouped/reclassified, wherever found necessary, to confirm to current period presentation.



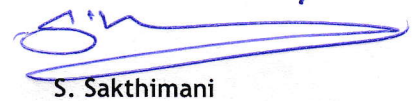
