To consider and if thought fit, to pass, the following resolution as Special Resolution:

“RESOLVED THAT pursuant to the provisions of section 149, 150, 152, Schedule IV and other applicable provisions, if any, of the Companies Act, 2013 and the rules notified thereunder (the “**Act**”), Regulations 16(1)(b), 17 and 25(2A) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, (the “**SEBI Listing Regulations**”), Section 10A (2A)

and other applicable provisions, if any, of the Banking Regulation Act, 1949, read with the rules, guidelines and circulars issued by the Reserve Bank of India (the “RBI”), from time to time and any other applicable laws (including any statutory amendments, modifications, variations or re-enactments thereto, for the time being in force), the provisions of the Articles of Association of The Federal Bank Limited (the “Bank”), pursuant to the recommendation made by the Nomination, Remuneration, Ethics and Compensation Committee of the Bank (“Committee”) and approval of the Board of Directors of the Bank (the “Board”), Mr. Sudarshan Sen (DIN: 03570051) who was appointed as a Non-Executive Independent Director on the Board of the Bank, and whose period of office as an Independent Director is liable to expire on February 10, 2025, and who has submitted a declaration that he meets the criteria of independence as provided in Section 149(6) of the Act and Regulation 16(1)(b) of SEBI Listing Regulations and who is eligible for re-appointment and in respect of whom the Bank has received a notice from a Member, in writing, under Section 160 of the Act, signifying the member’s intention to propose re-appointment of Mr. Sudarshan Sen as an Independent Director of the Bank, be and is hereby re-appointed as an Independent Director of the Bank, for a second term of 3 (three) years, with effect from February 11, 2025 to February 10, 2028, (both days inclusive), not liable to retire by rotation.

Item No. 2: Grant of 16,00,000 Stock Options to Mr. Krishnan Venkat Subramanian (DIN: 00031794), Managing Director & CEO of the Bank.

To consider and if thought fit, to pass, the following resolution as an Ordinary Resolution:

In compliance with Regulation 44 of the SEBI Listing Regulations as amended, and pursuant to the provisions of Sections 108 and 110 of the Act, read with the Rules and the MCA Circulars, the Bank is pleased to inform you that this Postal Ballot Notice of the Bank is being sent only through electronic means and has extended remote e-voting facility to all the members of the Bank to enable them to cast their votes through remote e-voting in respect of the business to be transacted vide this Postal Ballot Notice. The instructions for remote e-voting are appended to this Notice of Postal Ballot. For this purpose, the Bank has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency for providing services of e-voting. The facility of casting votes by a member using remote e-voting will be provided by NSDL.
2. The Explanatory Statement pursuant to the provisions of Section 102(1) of the Act read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Secretarial Standard – 2 (“SS-2”) on General Meetings issued by the Institute of Company Secretaries of India setting out material facts relating to the resolutions at Item Nos. 1 & 2 contained in this Postal Ballot Notice dated October 28, 2024, is annexed hereto.
3. In accordance with the MCA circulars, the physical copies of this Postal Ballot Notice, along with postal ballot form and postage pre-paid business reply envelope, are not being sent to any member. Accordingly, the communication of the assent or dissent of the members eligible to vote is restricted only to remote e-voting (“e-voting”) i.e. by casting their votes electronically instead of submitting postal ballot forms.
4. Brief profile and other requisite details about the re-appointment of Director pursuant to Regulation 36(3) of the SEBI Listing Regulations and Secretarial Standard – 2 (SS-2) on General Meetings issued by the Institute of Company Secretaries of India is annexed hereto and forms part of this Notice.
5. The Notice will also be placed on the website of the Bank at www.federalbank.co.in and on the e-voting website of National Securities Depository Limited at www.evoting.nsdl.com. 6. In compliance with the MCA circulars, the Bank is sending this Notice in electronic form only to those Members whose e-mail addresses are registered with the Bank/ Depositories and whose names appear in the Register of Members/ list of Beneficial Owners as received from National Securities Depository Limited (“NSDL”) and the Central Depository Services (India) Limited (“CDSL”)

9. SEBI vide its Circular bearing reference no. SEBI/HO/MIRSD/POD-1/P/CIR/2023/181 dated November 17, 2023, read with SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated May 07, 2024, has mandated that dividend, interest or redemption shall be paid only through electronic mode with effect from April 01, 2024.

Accordingly, no dividend shall be paid in case PAN, contact details, Bank A/c details and Specimen signature for the corresponding folio numbers of shareholders are not updated. Shareholders should update the same with the Bank/ RTA (in case holding shares in physical mode)/ Depository Participant (in case holding shares in electronic form) to ensure that the said dividend is credited to the designated bank account.

11. The voting rights of the members shall be in proportion to their shares in the total paid-up equity share capital of the Bank, as of the cut-off date. The voting rights of members cannot be exercised through proxy on the resolutions forming part of this postal ballot notice . A person who is not a Member of the Bank as on the Cut-Off date should treat this Notice for information purpose only. The detailed procedure with respect to e-voting is mentioned in this Notice.
12. The Board of Directors of the Bank had, appointed Mr. M. Damodaran (Membership No. 5837, CP No. 5081) or in his absence, Ms. J. Kalaiyarasi (Membership No. 29861, CP No. 19385) of M/s. M Damodaran & Associates LLP, Practising Company Secretaries, Chennai, to act as the Scrutinizer for conducting the Postal Ballot through e-voting process in a fair and transparent manner. The Scrutiniser has communicated his willingness to be appointed for the said purpose.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013 READ WITH RULE 20 and 22 OF THE COMPANIES (MANAGEMENT AND ADMINISTRATION) RULES, 2014 AND SECRETARIAL STANDARD-2 ON GENERAL MEETINGS FORMING PART OF THE NOTICE

The following statement sets out all material facts relating to the Special Business mentioned in the Notice:

Item no. 1

Re-appointment of Mr. Sudarshan Sen (DIN: 03570051) as a Non-Executive, Independent Director of the Bank

The Board of Directors had appointed Mr. Sudarshan Sen (DIN: 03570051) as an Additional Independent Director under Section 161 of the Companies Act, 2013 vide Circular Resolution approved on February 11, 2020. Mr. Sudarshan Sen was then appointed as an Independent Director of the Bank pursuant to Section 149 of the Companies Act, 2013 (“the Act”) read with Companies (Appointment and Qualification of Directors) Rules, 2014, the SEBI Listing Regulations, Section 10A and other applicable provisions of the Banking Regulation Act, 1949, by the Shareholders at the 89th Annual General Meeting of the Bank held on July 16, 2020 to hold office for a period of five (5) years with effect from February 11, 2020. Accordingly, the first term of Mr. Sudarshan Sen will end on February 10, 2025.

The Nomination, Remuneration, Ethics and Compensation Committee (“the Committee” or “NRC”) of the Board of Directors of the Bank (the “Board”) discussed the performance evaluation of Mr. Sudarshan Sen (DIN: 03570051) and considering his knowledge, acumen, expertise, experience and substantial contribution and time commitment, approved and recommended his reappointment as an Independent Director for the second term of 3 years effective from February 11, 2025, to February 10, 2028.

Pursuant to the recommendation of the NRC vide circular resolution dated October 09, 2024, the Board at its meeting held on October 10, 2024, recommended the re-appointment of Mr. Sudarshan Sen (DIN: 03570051) as an Independent Director of the Bank for the second term of 3 (Three) years effective from February 11, 2025 to February 10, 2028 (both days inclusive), subject to the approval of the members of the Bank.

The NRC and the Board has considered his diverse skills, leadership capabilities, expertise in Banking, Finance & Risk Management, Business Management and vast global business experience, among others, as being key requirements for this role. In view of the above, the NRC and the Board is of the view that Mr. Sudarshan Sen possesses the requisite skills and capabilities, which would be of immense benefit to the Bank, and hence, it is desirable to re-appoint him as an Independent Director. The Board at its meeting held on October 10, 2024, has approved and recommended the re-appointment of Mr. Sudarshan Sen as an Independent Director, not liable to retire by rotation, for a second term of 3 years effective from February 11, 2025, to February 10, 2028. In accordance with the provisions of Section 149 of the Companies Act, 2013, an Independent Director may hold office for two terms up to 5 consecutive years each. But as per Section 10A (2A) of The Banking Regulation Act, 1949, no director of a banking company, other than its chairman or whole-time director, by whatever name called, shall hold office continuously for a period exceeding 8 years.

Mr. Sudarshan Sen fulfils the requirements of an Independent Director as laid down under Section 149(6) of the Companies Act, 2013, and Regulation 16 of the SEBI Listing Regulations read with Section 10A (2A) and other applicable provisions, if any, of the Banking Regulation Act, 1949, read with the rules, guidelines and circulars issued by the Reserve Bank of India. He is not debarred from holding office of director by virtue of any SEBI order or any other such authority and he is not related to any

director of the Bank. The Bank has received all statutory disclosures/ declarations from Mr. Sudarshan Sen, including:

- (i) consent in writing to act as director in Form DIR-2, pursuant to Rule 8 of the Companies (Appointment & Qualification of Directors) Rules, 2014 (“the Appointment Rules”),
- (ii) intimation in Form DIR-8 in terms of the appointment Rules to the effect that he is not disqualified under sub-section (2) of Section 164 of the Act, and
- (iii) a declaration to the effect that he meets the criteria of independence as provided in sub-section (6) of Section 149 of the Companies Act, 2013 and Regulation 16(1)(b) of SEBI Listing Regulations.

The Bank has also received a notice under Section 160 of the Companies Act, 2013 from a member, intending to nominate Mr. Sudarshan Sen to the office of Independent Director. In the opinion of the Board and based on its evaluation, Mr. Sudarshan Sen is independent of the management of the Bank and fulfills the conditions specified in the Companies Act, 2013 and Rules made thereunder and SEBI Listing Regulations for his re-appointment as an Independent Director of the Bank. Further, the Board of Directors of the Bank is of the opinion that he is a person of integrity and has relevant experience and expertise for him to be re-appointed as an Independent Director of the Bank.

A copy of the draft letter for the re-appointment of Mr. Sudarshan Sen setting out the terms and conditions is available for electronic inspection without any fee by the members.

The resolution seeks the approval of members for the re-appointment of Mr. Sudarshan Sen as an Independent Director of the Bank effective from February 11, 2025, to February 10, 2028, pursuant to Sections 149, 152 and other applicable provisions of the Act and the Rules made thereunder (including any statutory modification(s) or re-enactment(s) thereof) and his office shall not be liable to retire by rotation.

The Board of Directors of the Bank recommends the resolution in relation to the re-appointment of Mr. Sudarshan Sen as an Independent Director of the Bank as set out in Item No. 01 for approval of the Members of the Bank by way of a Special Resolution.

Except Mr. Sudarshan Sen and his relatives, none of the other Directors, Key Managerial Personnel of the Bank or their respective relatives are in any way concerned or interested, financially or otherwise, in the Special Resolution set out in Item No. 01 of the accompanying Postal Ballot Notice.

Pursuant to Regulation 36 of SEBI Listing Regulations and Secretarial Standard 2, issued by the Institute of Company Secretaries of India, additional details and brief profile of Mr. Sudarshan Sen are annexed as Annexure A and Annexure C to this Notice. This explanatory statement may also be regarded as a disclosure under the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Item no. 2

Grant of 16,00,000 Stock Options to Mr. Krishnan Venkat Subramanian (DIN: 00031794), Managing Director & CEO of the Bank

In terms of Section 35B of the Banking Regulation Act, 1949, Reserve Bank of India conveyed its approval for appointment of Mr. Krishnan Venkat Subramanian (DIN: 00031794) as Managing Director & CEO of The Federal Bank Limited for a period of 3 years with effect from September 23, 2024. Further, Reserve Bank of India advised that the proposal for grant of additional one-time stock options to Mr.

Krishnan Venkat Subramanian as joining bonus, should be taken up with them separately as a specific proposal.

Pursuant to the recommendation of the Nomination, Remuneration, Ethics & Compensation Committee of the Board, the Board of the Bank, on August 10, 2024, had accorded in principal approval to grant additional one-time Stock Options to Mr. Krishnan Venkat Subramanian, as joining bonus and an application in this regard was submitted to the Reserve Bank of India.
