		exchange rates). This value represents the minimum estimated revenue, as the quantity of waste may increase over the five-year contract term. In addition, the Company may derive further value from recycled outputs generated from the collected waste, enabling revenue generation both from waste collection activities and from recovered and recycled materials.
