Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and other applicable provisions, if any, and in continuation of our earlier intimations dated January 18, 2024 and November 28, 2024, we wish to inform you that the Company's insurance claim in respect of the fire incident that occurred at a plant adjoining the Company's manufacturing facility situated at Plot No. W-124-A, Khervai, Badlapur (East), Maharashtra has been fully settled by Tata AIG General Insurance Company Limited for a total amount of INR 11,33,77,477/- (Rupees Eleven Crores Thirty-Three Lakhs Seventy-Seven Thousand Four Hundred and Seventy-Seven Only) towards property damage including inventory and loss of profit. The aforesaid settlements have been accepted as full and final.

1	Insurance amount claimed and realized by the listed entity for the loss/damage	Insurance claim in respect of the fire incident that occurred at a plant adjoining the Company's said manufacturing facility situated at Badlapur has been fully settled by Tata AIG General Insurance Company Limited for a total amount of INR 11,33,77,477/- (Rupees Eleven Crores Thirty-Three Lakhs Seventy-Seven Thousand Four Hundred and Seventy-Seven Only) towards property damage including inventory and loss of profit. The aforesaid settlements against the claim have been accepted as full and final.
2	The actual amount of damage caused due to the natural calamity or other force majeure events.	
3	Details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production or service, financials of the entity.	As informed earlier in the intimation dated January 18, 2024, the fire was successfully contained within a minimal timeframe, but operations of the said plant were temporarily disrupted. Fortunately, there was no loss to human life and the company initiated all adequate steps to ensure refunctioning of the plant. Further, in the intimation dated November 28, 2024, the company resumed plant manufacturing activities. There has been no material/significant adverse impact due to the said incident.
