- The Postal Ballot notice dated 28th October, 2025 as confirmed by the Company was sent to the shareholders in respect of the below mentioned resolutions passed at the Board meeting of the Company through electronic mode to those Members whose email addresses are registered with the Company/Depositories, in compliance with General Circular No. 09/2023 dated September 25, 2023 (read with previous Circulars) and Securities and Exchange Board of India ("SEBI") vide circular dated 07th October, 2023 (read with previous circulars) ("collectively referred to as Applicable Circulars").
