CJI-Designate Says He'll Strive To Provide Leadership, Long-Term Vision

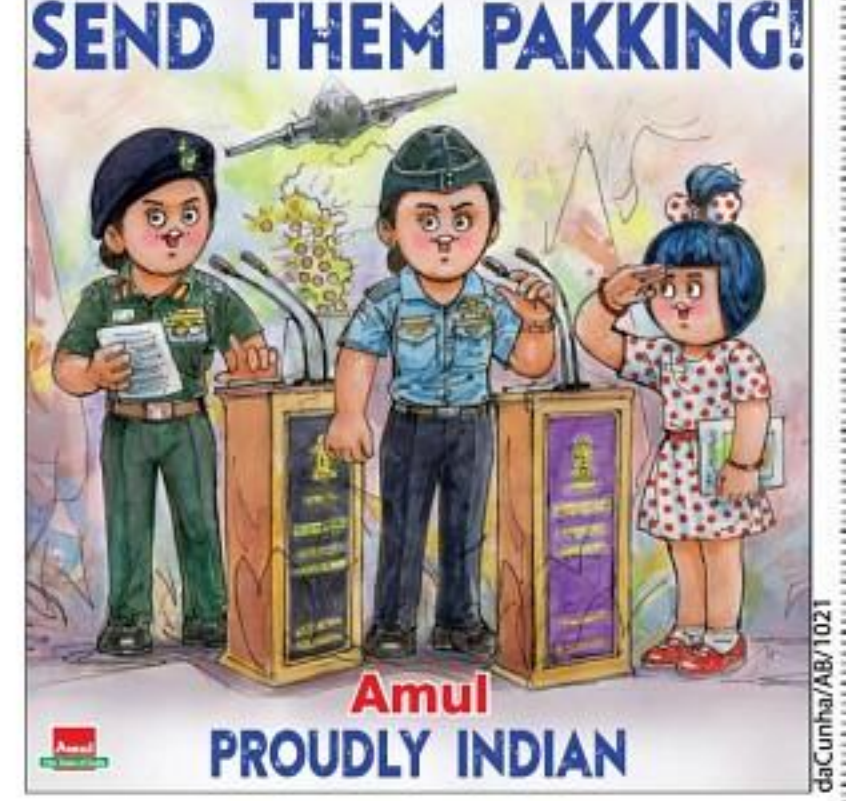

New Delhi: At a time when caustic rumours and speculation are rife in social media against high court judges, CJI-designate B R Gavai promised that as the next CJI he would strive to provide leadership and long-term vision for the institution of judiciary.

To assuage feelings of HC judges facing a barrage of rumours and speculation on social media, former CJI N V Ramana said CJI and SC judges have a moral and institutional duty to look after all judges

guard their rights and redress their grievances, they are less likely to seek support from other sources such as political and executive powers," he said. Maha to HC: Abu Salem's early release under consideration

Mumbai: Maharashtra govt has informed Bombay HC that the proposal for premature release of extradited gangster Abu Salem is under consideration, and a decision will be taken on it soon.

Farhana Shah, Salem claimed he had already undergone the 25-year imprisonment term if remission for good behaviour was included. The plea stated when Salem was extradited from Portugal, govt had assured he would not be handed death penalty in any case and that he would not be imprisoned for a term beyond 25 years.

False charge: Chennai bus conductor wins 5-year-long legal battle

Chennai: A bus passenger's mistaken act of picking up a soiled ticket from the floor spiralled into a false misconduct charge, illegal salary recovery, and a five-year legal battle for a Metropolitan Transport Corporation (MTC) conductor.

After years of struggle, Madras high court (HC) ordered a refund of the recovered amount and settlement of his terminal benefits. The incident dates back to 2019, when a woman passenger at Chennai Central produced two tickets during a routine inspection — one valid and another soiled one she accidentally picked up from the bus floor.

100 flights cancelled at IGI Airport, over 200 delayed; many passengers affected

New Delhi: Air travel to and from the Delhi airport were impacted on Thursday as well due to the changing airspace conditions. Seventy-nine domestic and 11 international flights were cancelled. According to FlightRadar24, over 200 flights were delayed.
