**Sub: Clarification on financial results submission for the period ended September 30, 2025**

This is in reference to your email dated 13th January 2026, regarding the deficiency observed in the financial results submitted by FlySBS Aviation Limited on November 14, 2025. The observation stated was:

*“Financial results submitted is not as per format prescribed by SEBI - Auditor Certificate on Utilisation of Issue Proceeds not given.”*

In this regard, we would like to clarify as under:

1. The company has appointed M/s Care Ratings Limited as the Monitoring Agency to monitor the utilisation of IPO proceeds. Accordingly, in terms of NSE Circular No. NSE/CML/2024/23 dated 05 September 2024, the requirement for submission of an Auditor's Certificate on utilisation of issue proceeds along with financial results is not applicable to SME listed entities where a Monitoring Agency has been appointed.
2. The Monitoring Agency Report for the period ended September 30, 2025 has been submitted within the prescribed timeline of 45 days and the acknowledgement is enclosed herewith for reference.

We trust the above adequately addresses and clarifies the observation raised. You are requested to kindly take the same on record and confirm that the submission is in order.
