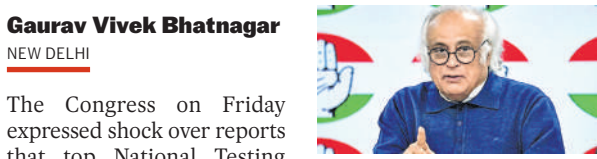

Cong slams NTA DG over 'no paper leak' remarks



The Congress on Friday expressed shock over reports that top National Testing Agency (NTA) officials informed a parliamentary standing committee that the NEET-UG question paper did not leak through its internal system. The controversial paper leak had earlier resulted in the cancellation of the exam and sparked a probe by the CBI. Calling the NTA Director General's remarks "scandalous and shockingly dishonest", Congress leader Jairam Ramesh said the stance proves there is an active attempt to cover up the leak. He demanded strict accountability from Prime Minister Narendra Modi and the Union Education Minister.

Attacked in Gaya, Union minister escapes unhurt

Union Minister Jitan Ram Manjhi escaped unhurt after a youth threw a stone at him during a public event in Gaya district on Friday. The incident occurred at Siswar village when Manjhi was addressing the gathering. While the stone missed the Union Minister, it struck his personal bodyguard, causing minor injuries. Police personnel deployed at the venue swiftly detained two youths for their suspected involvement in the attack and are interrogating them to ascertain whether the incident was premeditated.

Security concerns have mounted in the region following a similar targeted encounter last Sunday. The convoy of MLA Jyoti Manjhi, the 'samdhin' of the Union Minister, was blocked by a passenger vehicle in Gambhirra village. When security staff requested the driver to clear the path, around 15 to 20 occupants stepped out and physically assaulted the bodyguards. The legislator, who remained inside her vehicle during the ruckus, alleged that the attackers hurled casteist slurs.

Landslide in Shimla Act of God: NHA to NGT

New Delhi: The National Highways Authority of India (NHA) has told the National Green Tribunal that it is not liable to pay compensation to owners of agricultural land as the May 2025 landslide that occurred in Shimla was an 'Act of God'. The NHA submitted its reply against the plea filed in January, claiming that the heavy construction work being undertaken by the authority and its concessionaire, had damaged agricultural land in Shimla rural tehsil, causing landslides.

SC to hear plea on CBSE 'three language' plan

New Delhi: The Supreme Court on Friday said it will hear next week a plea challenging the new policy of CBSE which has made study of three languages, including at least two native Indian languages, compulsory for Class 9 students from July 1.

Senior advocate Mukul Rohatgi mentioned the matter before a bench of Chief Justice Surya Kant and Justices Jayacharya Bagchi and Vipul M Pancholi. "This is an urgent PIL. The petitioners are students, teachers and parents. They are challenging the new policy of the CBSE," Rohatgi said.

Centre to SC: Will bring some deportees back from B'desh

The Centre on Friday told the Supreme Court that it has decided to bring back some people, who were earlier deported to Bangladesh, to India and would then verify their claim of Indian citizenship. Solicitor General Tushar Mehta, appearing for the Centre, told a bench headed by Chief Justice Surya Kant that keeping in view the peculiar facts and circumstances of the case and by not treating it as a precedent to be followed in other matters, the government has decided to bring them back.

"The government would bring them back and thereafter examine their status," Mehta told the bench. The top law officer said that it may take 8-10 days to bring these persons back to India. The bench posted the matter for hearing in July. The top court was hearing a plea of the Centre challenging a September 26, 2025 order of the Calcutta High Court by which it had set aside the central government's decision to deport Sunali Khatun and others to Bangladesh and termed it as "illegal".
