Opinion:-

We have audited the accompanying financial statements of half yearly and year to date financial results of **SP Refractories Limited (Formerly known as 'SP Refractories Private Limited')**, for the half year and year ended March 31 2024 ("Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 and 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the statement:

Basis for Opinion:-
