Sub: Disclosure in terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Intimation regarding First Tranche Long Stop Date

Dear Sir / Madam,

In continuation of our earlier intimations dated (i) October 07, 2025 regarding proposal to enter into a Joint Venture Agreement with SK Enmove Co., Ltd. (“SKEN”); (ii) October 15, 2025 regarding execution of the Joint Venture Agreement; (iii) November 30, 2025 regarding initiation of incorporation activities for the Joint Venture Company; (iv) December 18, 2025 regarding incorporation of a Wholly Owned Subsidiary of the Company under the name “SK Enmove Gabriel India Private Limited” (“JV Co.”) and (v) December 31, 2025 regarding revision of First Tranche Long Stop Date to February 28, 2026, we wish to inform you that the First Tranche Conditions Precedent (as defined in Joint Venture Agreement) have been fulfilled and equity shares have been allotted today by SK Enmove Gabriel India Private Limited (“JV Co.”) to SK On Co., Ltd (due to merger of SKEN in SK On Co., Ltd) and Gabriel India Limited in the ratio 51:49, respectively. February 27, 2026 shall be considered as First Tranche Long Stop Date.

Further, note that the following agreements have also been executed:

- Technology License Agreement (“TLA”) between SK On Co., Ltd and JV Co. to procure technological information, support and assistance for Business from SKEN.
- Corporate Service Agreement (“CSA”) between Anand Automotive Private Limited (“AAPL”), and JV Co. to procure certain operational and management support services for Business from AAPL.
- ZIC Trademark Brand License Agreement between SK On Co., Ltd and JV Co. to enable JV Co. to use the ‘ZIC’ trademark; and
- Business Transfer Agreement (“BTA”) between SK Enmove India Private Limited (“SKEN India”) and JV Co. to buy the existing business of SKEN India by the JV Co.
- Joinder Agreement between SK On Co., Ltd, Gabriel India and JV Co. to record the accession of JV Co. to the terms and conditions of JVA.

You are requested to take the above on record.
