## 5. Reclassification:

The chairman placed on record the Complaint received from SEBI via email dated February 10, 2023 of Mr. Solanki Zankarsinh Kishorsinh and Giraben Kishorsinh Solanki with SEBI wherein he mentioned that he along with his family does not want to continue as a promoter of the company (1st para of the complaint).
