



Opinion

- 1 The above standalone financial results were reviewed by the Audit Committee and subsequently approved by the Board of Directors at their respective meetings held on April 25, 2025. The half-yearly figures have also been reviewed by the Audit Committee and approved by the Board of Directors at their
- 2 The standalone financial result for the quarter & year ended March 31, 2025 have been prepared in accordance with the requirement of Accounting Standard (AS) prescribed under Section 133 of the Companies Act 2013 read with relevant rules thereunder and in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations,

As per MCA notification dated 16th February 2015 companies whose share listed on SME exchange as referred to in chapter XB of SEBI (issue of capital and disclosure requirements) Regulations 2009, are exempted from the compulsory requirement of adoption of IND-AS. Hence, as the Company is covered under exempted category, it has not accepted IND-AS for preparation of financial results.

3 The figures of the quarter ended March 31, 2025 are the balancing figures between audited figures in respect of the full financial year ended March 31, 2025 and un-audited figures of Nine months ended December 31, 2024.
