**Sub.: Update on the work contract under Regulation 30 of SEBI (LODR) Regulations, 2015**

**Ref.: Intimation of Receipt of work contract under Regulation 30 of SEBI (LODR) Regulations, 2015 filed to the stock exchange on September 2, 2025**

Ganesh Infracore Limited (“**the Company**”) refers to its earlier disclosure dated September 2, 2025 regarding receipt of an order aggregating to Rs. 708.00 Crores from Kandoi Transport Limited (“**Kandoi**”) for comprehensive operation and maintenance of heavy mining equipment at the Nigahi Mine, Singrauli (Madhya Pradesh) for a period of 24 months, on a subcontract basis.

The Company would like to inform the Exchange that as the Company has acquired 60% equity stake in Kandoi, pursuant to which Kandoi has become a subsidiary of the Company.

Post acquisition, a strategic review of operations has been undertaken. In order to enhance operational efficiency and streamline execution, it has been decided that the balance unexecuted portion of the contract shall be executed directly by Kandoi.

The status of order execution as on date is as under:

Accordingly, the order book of Ganesh Infracore Limited shall stand reduced by Rs. 568.41 Crores, being the unexecuted portion of the aforesaid contract.

This is an internal arrangement within the group and does not involve any third-party transaction or change in the overall project scope. The said restructuring is expected to result in better operational alignment and efficiency at the group level, without any adverse impact on the overall business prospects of the Company.
