**Sub.: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), and further to the clarification sought by the Exchange, we hereby submit the following disclosure:

**1. Name of the Authority**

Directorate of Enforcement ("ED"), Government of India.

**2. Nature and details of the action taken**

The Directorate of Enforcement had conducted a search at the premises of Ganesh Infraworld Limited ("Company") on January 20, 2026.

The Company clarifies that the aforesaid search was initiated against the Partnership Firm Ganesh International and no proceedings/investigation were initiated against the Company pursuant to the said search. The search at the Company's premises was conducted in connection with an investigation being carried out by the Directorate of Enforcement in relation to certain other entities/persons.

The Company had extended full cooperation to the authorities and provided the information/documents sought during the proceedings.

As on the date of this disclosure, there is no attachment, seizure, freezing order or other restriction continuing against the assets of the Company pursuant to the aforesaid search.

**3. Clarification regarding erstwhile partnership firm**

The Company further clarifies that the erstwhile partnership firm Ganesh International was not in existence on the date of the aforesaid search. The business of the erstwhile partnership firm had already been succeeded by Ganesh Infraworld Limited prior to the date of the search.

**4. Impact on the Company**

The aforesaid search did not have any material impact on the business operations or financial position of the Company, and the Company's business operations continued in the ordinary course.

## 5. Explanation for delay in disclosure

At the time of the search, the Company understood that the proceedings were not initiated against the Company and were in connection with an investigation pertaining to other entities/persons. Accordingly, based on the Company's understanding of the facts and circumstances at the relevant time, the event was not considered to require a disclosure under Regulation 30 of the SEBI LODR Regulations.

Subsequently, pursuant to the clarification sought by the National Stock Exchange of India Limited and the discussions held with the Exchange, the Company is making the present disclosure in the interest of abundant caution, transparency and good corporate governance.

The Company regrets the delay, if any, in making the disclosure.

The Company shall continue to comply with all applicable disclosure requirements under the SEBI LODR Regulations.
