- Allcargo Supply Chain Private Limited ("ASCPL" Transferor Company 1);
- Gati Express and Supply Chain Private Limited ("GESCPL" Transferor Company 2);
- Allcargo Gati Limited (formerly known as GATI Limited) ("AGL" Transferor Company 3 / Transferee Company 1); and
- Allcargo Logistics Limited ("ACL" Transferee Company 2 / Demerged Company).

We wish to inform you that Form INC-28 along with the certified copy of the NCLT Order has been filed today, November 1, 2025, with the Registrar of Companies, Mumbai. Accordingly, the Scheme has become effective from November 1, 2025 ("Effective Date") pursuant to Clause 40 of the Scheme.

Consequently, Allcargo Gati Limited stands amalgamated with and into Allcargo Logistics Limited and has ceased to exist as a separate legal entity from the Effective Date.

In view of the above, the Board Meeting of Allcargo Gati Limited, scheduled on November 5, 2025, to consider and approve the unaudited financial results for the quarter ended September 30, 2025, stands cancelled.
