In accordance with Regulation 30 read with Para B of Part A of Schedule III of the Listing Regulations and SEBI circular dated July 13, 2023, in connection therewith, the Company would like to inform that the arbitration proceeding has been filed against the Company in the matter of Section 9 of the Arbitration & Conciliation Act, 1996 before High Court of Judicature at Bombay Ordinary Original Civil Jurisdiction Commercial Arbitration by Neomile Corporate Advisory Limited for the grant of interim measures of protection of Rs. 29,20,50,000/- (inclusive of GST) due under an arrangement with respect to alleged advisory services in connection with the Initial Public Offering ("IPO") of the Company.

The Company reiterates that the petition filed by Neomile Corporate Advisory Limited is frivolous, unsubstantiated, premised on fundamental factual misstatements and contrary to the overwhelming facts and evidence.
