Sub : Intimation of Non-Submission of Unaudited Financial Results for the Quarter Ended 31st December, 2024-Reg.

Dear Sir/Madam,

With reference to the captioned subject, we wish to inform you about Non-submission of the Unaudited Financial Results of the Company for the quarter ended 31st December, 2024.

The non-submission is attributable to extraordinary circumstances arising from the commencement of the Corporate Insolvency Resolution Process (CIRP) on 15th November 2022, which resulted in significant disruptions in the Company's operations and management. The transition in management, coupled with financial distress, has caused substantial challenges in the collection and review of requisite data for timely submission. Additionally, the resignation and unavailability of Key Managerial Personnel (KMP) and other critical staff necessary for handling specialized financial reporting tasks have further contributed to the delay.

Further to our earlier submissions w.r.t statutory audit pending for the FY 2022-23 and 23-24, the limited review audit for the quarter ended 31st December, 2024 is also pending.

The Company is making every effort to resolve these challenges and complete the process at the earliest.
