Dear Sir/Madam,

With reference to your email dated June 11, 2026, seeking clarification on the financial results submitted by the Company, pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 wherein the Consolidated PAT figures not matching with PDF submitted on May 16, 2026, for the quarter and financial year ended March 31, 2026.

The Company hereby confirms that the Consolidated PAT as mentioned in the signed PDF is correct, i.e., ₹2356.91 lakhs It is further clarified that the discrepancy in the XBRL filing occurred due to clerical error, wherein the tax figure was incorrectly captured as ₹649.97 lakhs instead of ₹496.33 lakhs, resulting in an incorrect PAT being reflected in the XBRL submission.

We confirm that the above-mentioned error has been rectified and the revised Integrated Filing (Finance) XBRL for the quarter and financial year ended March 31, 2026 has been duly updated and filed with the correct figures. A screenshot of the revised filing is attached herewith for your reference.
