Opinion

We have audited the accompanying Statement of Standalone Financial Results for the quarter and year ended on March 31, 2024 of **M/s. Geecee Ventures Limited** ("the Company") ("the Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations")

In our opinion and to the best of our information and according to the explanations given to us, the Statement for the year ended March 31, 2024:

- i. is presented in accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended; and

Materiality is the magnitude of misstatements in the Annual Consolidated Financial Results that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the Annual Consolidated Financial Results may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the Consolidated Financial Results.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33(8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, to the extent applicable.



Other Matters

The Statement includes the results for the Quarter ended March 31, 2024 being the balancing figure between audited figures in respect of the full financial year and the published year to date figures up to the third quarter of the current financial year which were subject to limited review by us. Our report is not modified in respect of this matter.

We did not audit the financial statements | financial results of the four subsidiaries included in the consolidated financial results, whose financial statements | financial results reflect total assets (before consolidation adjustments) of Rs.579.71 lakhs as at March 31, 2024, total income (before consolidation adjustments) of Rs. 8.18 lakhs and Rs. 30.66 lakhs, total net profit/(loss) after tax (before consolidation adjustments) of Rs. (2.68) lakhs and Rs. (8.58) lakhs and total comprehensive income/(loss) (before consolidation adjustments) of Rs. (2.68) lakhs and Rs. (8.58) lakhs for the quarter ended March 31, 2024 and the year ended on that date respectively, and net cash outflow of Rs. 3.61 lakhs for the year ended March 31, 2024, as considered in the Statement. The financial statements | financial results of these subsidiaries have been audited | reviewed, as applicable, by other auditor whose reports have been furnished to us by the Management and our opinion and conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of this subsidiary is based solely on the reports of the other auditor and the procedures performed by us as stated under Auditor's Responsibilities section above. The audited consolidated financial statements | consolidated financial results also include the Group's share of net profit / (loss) after tax (before consolidation adjustments) of Rs. (0.00) lakhs & Rs. (0.06) lakhs and total comprehensive profit/(loss) (before consolidation adjustments) of Rs. (0.00) lakhs & Rs. (0.06) lakhs for the quarter ended March 31, 2024 and the year ended on that date respectively in respect of one joint venture, based on their unaudited standalone financial statements | financial results. According to the information and explanation given to us by management, these standalone financial statements | financial results are not material to the Group.

Our report on the Statement is not modified in respect of the above matter with respect to our reliance on the work done and the reports of the other auditor.
