Notice is hereby given that the 34th Annual General Meeting (AGM) will be convened on Monday, September 25, 2023 at 11.00 a.m. through Video Conferencing (VC)/Other Audio Visual Means (OAVM) facility to transact the business as set out in the Notice of the AGM. The Notice of the 34th AGM and the Annual Report shall also be available on the website of the Company at www.geekywires.com and also on the website of National Stock Exchange of India Limited at www.nseindia.com.

In terms of MCA Circular, the Notice of the 34th AGM and the Annual Report has been sent by email to those shareholders whose email address is registered with the Company. The requirement for sending Notice & Annual Report of 34th AGM by physical mode has been dispensed with vide MCA Circular/SEBI Circular(s).

In compliance with Section 108 of Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rule 2014, as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the members are provided with the facility to cast their votes on resolution set out in the Notice of the AGM through electronic voting (e-voting) system provided by Big Share Services Pvt. Ltd. The voting rights shall be in proportion to the equity shares held by them in the equity share capital of the company as on September 18, 2023 ("cut-off date"). The Books of Share Transfers and Register of Members will be closed from September 19, 2023 till September 25, 2023 (both days inclusive) for the purpose of the 34th Annual General Meeting of the Company. For the purpose of dividend, the Company has fixed September 18, 2023 as the record date for entitlement of Dividend to Members for the dividend amount if declared and approved by the Members in the Annual General Meeting.
