Report on Postal Ballot through e-voting

This has reference to my appointment as Scrutinizer by the Board of Directors of **Genesys International Corporation Limited** (hereinafter the "**Company**") through passing of circular resolution and seeking consent of its shareholders for passing of following resolutions by Postal Ballot through e-voting, vide its Notice of Postal Ballot dated 30th January, 2025:

1. Appointment of Mr. Ajay Harish Aggarwal (DIN: 02437996) as a Non-Executive Independent Director- Special Resolution

in terms of

- a. Provisions of section 108 and 110 of the Companies Act, 2013 and all other applicable provisions, if any, read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014;
- b. the Secretarial Standard – 2 on General Meetings issued by the Institute of Company Secretaries of India;
- c. General Circular No.14/2020 dated 8th April, 2020, General Circular No.17/2020 dated 13th April, 2020, General Circular No.22/2020 dated 15th June, 2020, General Circular No.33/2020 dated 28th September, 2020 and General Circular No.39/2020 dated 31st December, 2020, Circular No.10/2021 dated 23rd June, 2021, Circular No.20/2021 dated 8th December, 2021, Circular No.3/2022 dated 5th May, 2022, Circular No.11/2022 dated 28th December, 2022, Circular No.9/2023 dated 25th September, 2023 and Circular no. 09/2024 dated 19th September, 2024 issued by



- the Ministry of Corporate Affairs, respectively (collectively referred to as "MCA Circulars");
- d. And other applicable provisions of the Act, rules, regulations, circulars and notifications, if any, including any statutory modification(s), clarification(s), substitution(s) or re-enactment(s) thereof for the time being in force;

Management's Responsibility:

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules made thereunder relating to Postal Ballot through e-voting. My responsibility as Scrutinizer is restricted to make Scrutinizer's Report of the votes cast by shareholders of the Company on the resolutions contained in the respective Notice of Postal Ballot dated 30th January, 2025, based on the report generated from e-voting system provided by the National Securities Depository Limited (hereinafter the "NSDL"), the authorized agency appointed by the Company for providing postal ballot through e-voting facilities.

In this connection, I hereby submit my report as under:

1. The Company has sent Notice of Postal Ballot pursuant to Section 110 of the Companies Act, 2013, read with rules made there under, through electronic mode alone, to the members of the Company whose names appeared in the Register of Members/ statements of Beneficial Ownership maintained by the Depositories namely, National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on Friday, 24th January, 2025 and completed the sending of Notice of Postal Ballot, on 31st January, 2025.
2. As per relevant MCA Circulars, physical copies of the Notice of Postal Ballot, Postal Ballot Forms and pre-paid Business Reply Envelopes are not being sent to members for this Postal Ballot.
3. As prescribed in the Rule 20 of Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published in English in "Free Press Journal" newspaper dated 1st February, 2025 and in Marathi in "Nav Shakti" newspaper dated 1st February, 2025.
4. The e-voting period commenced from 9.00 a.m. (IST) on Sunday, 2nd February, 2025 and ended on 5.00 p.m. (IST) on Monday, 3rd March, 2025.



5. I have considered, for the purpose of my Report, all the votes cast through electronic mode up to 05.00 p.m. on Monday, 3rd March, 2025, i.e. the last date and time fixed by the Company for voting by electronic means.
6. During the process of Voting by electronic means I have been assigned by and have relied upon the secured system provided by the National Securities Depository Limited (NSDL) for validation of voting by electronic means. Reports for voting for each resolution are generated from e-voting website of NSDL, by unblocking the data after 5.00 p.m. on 3rd March, 2025 i.e. on 6.35 p.m. on 3rd March, 2025 in presence of two witnesses. The voting by electronic means was made validated with software controls.
7. The Postal Ballot Report generated from NSDL website and all other related papers are kept under my safe custody. I shall return them in due course by separate letter for safe preservation till the resolution is given effect to.
8. I now submit my Report as under on the result of the voting by Postal Ballot in physical and electronic mode in respect of above resolutions:


