PROCEEDINGS OF 33rd ANNUAL GENERAL MEETING OF THE COMPANY

The 33rd Annual General Meeting (“AGM”) of the Company was convened and held on Thursday, September 18, 2025 at 12:30 PM (IST) through Video Conferencing (“VC”) /Other Audio-Visual Means (“OAVM”) facility.

The meeting commenced at 12:30 PM.

Mrs. Nalini Singh, Company Secretary & Compliance Officer, welcomed the Members to the Meeting and briefed them on details relating to their participation at the Meeting through audio-visual means.

Mrs. Shivani Jain, Chairman of the Board, chaired the Meeting. The Chairman welcomed the Shareholders to the Meeting and on requisite quorum being present, called the Meeting to order and highlighted certain points as meeting was conducted through VC/OAVM as follows:

- The meeting being held through VC/OAVM, in compliance with the provisions of the Companies Act, 2013 and relevant circulars issued by the Ministry of Corporate Affairs, Government of India (MCA) & Securities and Exchange Board of India (SEBI).
- As the AGM was held through VC, the facility for appointment of proxies by the members was not applicable and hence the proxy register was not available for inspection.
- The Company received request from shareholders to register themselves as speaker at the AGM and chairman addressed their queries and answered them.
- As the AGM was convened through VC, resolutions were put to vote through remote e-voting prior to the AGM and the requirement to propose and second was not applicable.

The Chairperson called the meeting to order as requisite quorum was present. The Chairperson introduced herself and the invitees present at the meeting.

The Chairperson informed that in view of the circular issued by Ministry of Corporate Affairs, the AGM was conducted through VC / OAVM. This meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI).

The Chairperson informed that the Company had tied up with National Securities Depository Limited (NSDL) to provide facility for voting through remote e-voting and for participation in the AGM through VC / OAVM facility.

The Chairperson informed the Members that the Report of Board of Directors, the Accounts for the financial year ended 31st March, 2025 and the Notice convening the 33rd AGM were taken as read as the same had already been circulated to the Members. As there were no qualifications in the Audit Report, it was not required to be read.

The Chairperson informed the Members that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e-voting commenced at 09.00 a.m. on Monday, 15th September, 2025 and ended at 5.00 p.m. on Wednesday, 17th September, 2025.

The Company Secretary informed the Members that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote through remote e-voting.

The Company had appointed Mr. Nitin Nagar, Practicing Company Secretary, as the Scrutiniser for the purpose of scrutinising the process of remote e-voting and e-voting during the AGM.

The Chairperson addressed the meeting with her speech.
