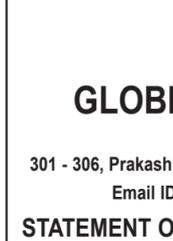

आरबीआई ने बैंक ऑफ महाराष्ट्र, सीएसबी बैंक, नवी फिनसर्व और अन्य पर लगाया जुर्माना

बिजनेस रेमेडीज/मुंबई। भारतीय रिजर्व बैंक (आरबीआई) ने निर्देशों का पालन न करने के लिए बैंक ऑफ महाराष्ट्र, डीसीबी बैंक और सीएसबी बैंक पर मौद्रिक जुर्माना लगाया। आरबीआई ने विज्ञापित किया कि केंद्रीय बैंक ने बैंक ऑफ महाराष्ट्र पर 32.50 लाख रुपये, डीसीबी बैंक पर 29.60 लाख रुपये और सीएसबी बैंक पर 63.60 लाख रुपये का जुर्माना लगाया है। विज्ञापित किया कि आरबीआई ने नवी फिनसर्व पर 3.80 लाख रुपये का जुर्माना लगाया जबकि आईआईएफएल फाइनेंस पर 5.30 लाख रुपये का जुर्माना लगाया है। बैंक ऑफ महाराष्ट्र पर यह मौद्रिक जुर्माना इसलिए लगाया गया क्योंकि बैंक ने स्वयं सहायता समूह के सदस्यों से संबंधित डेटा क्रेडिट सूचना कंपनियों को नहीं दिया और कुछ खातों में वास्तविक मालिकों की पहचान नहीं की। आरबीआई ने कहा कि सीएसबी बैंक पर जुर्माना लगाने का कारण बैंक प्रतिनिधि के साथ ऐसे कार्यों के लिए समझौता किया जो उनके निर्धारित दायरे से बाहर थे। साथ ही, बैंक ने कुछ बचत खातों में शुल्क लगाए, लेकिन ग्राहकों को इन शुल्कों की पहले से स्पष्ट जानकारी नहीं दी।
