In terms of Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirement) Regulations 2015, it is hereby informed that there has been a fire incidence took place at Nonwoven Unit located at Plot No. 205-207, GIDC Industrial Area, Panoli, Ankeleshwar, Distt. Bharuch, Gujarat-394116 of the Company on September 15, 2025 at about 02.00 A.M.

There was minor damages of Cables of Blow-Room and Carding Section. The fire was brought under control within 20 (twenty) minutes by Company's own fire extinguishers. The production operation of the said Unit is temporarily disrupted for a couple of days and there is no human injury or casualties reported. The Company is in the process of ascertaining of actual loss caused by the fire and necessary intimation has been sent to the Insurer.
