In the said disclosure, the number of shares acquired was incorrectly mentioned as 2,499 instead of the correct figure of 2,449. As a result, the total shareholding post-acquisition was also inaccurately stated by **MIDASTECH VENTURES PRIVATE LIMITED (Previously known as Mighty Overseas Private Limited), promoter of GLOBAL EDUCATION LIMITED (CIN: L80301MH2011PLC219291)**
