I hereby tender my resignation from the position of **IT Head of Global Education Limited**, with effect from **15<sup>th</sup> November 2025**.

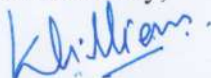
This decision has been taken after careful consideration due to **professional commitments**, and I believe this is the appropriate time for me to step down and enable a smooth leadership transition within the IT function.
