Dear Sir/Madam,

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we hereby inform you that the Company had received a demand notice under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 ("SARFAESI Act") from ICICI Bank Limited in respect of the credit facilities availed by the Company.

Upon receipt, the Company undertook an internal assessment of the notice, including verification of its contents, evaluation of materiality in terms of the Company's Policy for Determination of Materiality of Events and Information. The Company was also engaged in discussions with the lender during this period.

Subsequently, it came to the attention of the management that the lender had published a public notice in The Free Press Journal (Mumbai Edition) dated July 2, 2026 in connection with the aforesaid SARFAESI proceedings. The Company has already submitted its detailed representation to ICICI Bank Limited on July 8, 2026, setting out its response to the demand notice and requesting appropriate consideration, and the matter is presently under consideration by the lender. Accordingly, the Company is making the present disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The details required under Regulation 30 read with the applicable SEBI Master Circular are enclosed as **Annexure A**.

The Company shall continue to keep the Stock Exchange informed of any further material developments in accordance with applicable laws and regulations.
