These equity shares were allotted on March 28, 2024. Additionally, this move ensures the group's facility is compliant with Zero Liquid Discharge (ZLD) and Zero Discharge of Hazardous Chemicals (ZDHC) standards, demonstrating a strong commitment to environmental sustainability.
