Awami League ramps up pressure on Yunus as confrontation mounts

BANGLADESH

The political standoff in Bangladesh deepened on Friday as the Sheikh Hasinaled Bangladesh Awami League intensified its agitation against the interim government headed by Nobel laureate Muhammad Yunus. With Yunus under increasing pressure after announcing that a referendum will be held alongside national elections—a long-standing demand of a hardline Islamist party—the Awami League has rolled out an expanded protest calendar.

"Our struggle will continue... Nationwide protests, demonstrations, and resistance programmes on Friand Saturday, day November 14 and 15. A total nationwide shutdown on Sunday and Monday, November 16 and 17. The movement will continue until Yunus resigns," the party declared.

The Awami League claims its lockdown in Dhaka has been "immensely successful" and says more protests across the weekend will further tighten the screws on the interim administration. In a strongly worded statement, the party described Dhaka's current paralysis as a symbolic uprising:

"Today... the word 'lockdown' has returned with a new mission. It is not for public health, but for national survival. Dhaka stands still... beneath the calm lies the thunder of a nation's heart."

The political temperature has surged ahead of November 17, when the International Crimes Tribunal is scheduled to deliver its verdict against former Prime Minister Sheikh Hasina in absentia. Accused of crimes against humanity, Hasina has rejected the charges as politically motivated, saying her ouster was orchestrated by foreign powers backing Yunus.

The interim government, however, insists the Awami League's protests have failed. The Chief Adviser's Press Wing dismissed a viral video of Dhaka Metropolitan Police Commissioner Sheikh Mohammad Saijat Ali purportedly supporting the "lockdown", calling it AIgenerated misinformation.

Security across Dhaka has been tightened, checkpoints erected, and public gatherings restricted. Police have reportedly arrested Awami League supporters for alleged sab-

The LDA, a coalition of six leftist parties, called the move "one-sided and unconstitutional", arguing that the constitution provides no mechanism for such an order. Storm Claudia causes disruption, flooding in England

The UK Environment Agency on Saturday warned that while weather conditions are now more settled, ongoing river flooding impacts remain likely following Storm Claudia. The recent heavy rainfall associated with Storm Claudia has led to widespread disruption, and flood risk remains in place across parts of England. Ongoing river flooding impacts are still probable throughout today, with residual minor flooding on some larger rivers expected to continue through to Tuesday, the agency stated. While the Met Office's rain and wind warnings have now expired, there were about 58 flood warnings and 150 flood alerts - meaning flooding is possible - around Saturday noon, UK time.

Ind supply Brahmos to Philippines

India has long sought a foothold in the global arms market and its first major export of the BrahMos system to the Philippines marks its emergence as a defence exporter of an advanced missile technology, a report said on Saturday. Four killed, six injured in explosion in Pakistan



ANI HYDERABAD

At least four people were killed and six others injured after a massive explosion ripped through an illegal fireworks factory in Hyderabad, Sindh, on Friday, officials told.

The blast occurred at a firecracker unit operating out of a residential house near the Laghari Goth river under the Latifabad Police Station B Section limits, triggering a fire that quickly engulfed the structure. A duty doctor at Liaquat University Hospital confirmed that one body was brought dead

and six injured victims were admitted with moderate to severe burn wounds. Another doctor reported that two of the injured had nearly 100% burns. Medico-legal officer Dr Mohammed Hussain said two unidentified bodies were shifted to the mortuary, another charred body was taken to the burns ward. Latifabad Assistant Commissioner said the factory was being run illegally without licence. Hyderabad SSP Adeel Chandio stated that authorities were verifying licensing details and investigating the ownership of the facility.
