Dear Sir / Madam,

With reference to our earlier communication dated October 30, 2025, regarding the successful establishment and operationalization of a new manufacturing facility at Modasa, Gujarat, we are pleased to share an update on the commencement of production at the facility.

The company has successfully completed the Trail run and has started Commercial production of its Namkeen Facility. Details of Plant are as under:

- **Installed Capacity (Restore of Rajkot Facility):** 63,085 MT, with plans to gradually scale up over the time.
- **Product Portfolio:** Gathiya and Namkeen
- **Operational Strategy:** This plant will target to service Part of Gujarat (other than Saurashtra and Kutch), Rajasthan, Madhya Pradesh and part of Maharashtra.

Wafers and Snacks Pallets continue to be manufactured at Modasa as it was earlier. Now with this Namkeen Facility becoming fully Operational, this plant will be able to cater almost full basket of dealer requirement from single location.

Post Fire incident at Rajkot last year, major hurdle in growth was Supply Chain since different products were manufactured at different locations, resulting in higher order service time and inconvenience to dealers.

With starting of Commercial Production at Modasa facility, company is confident that majority of Supply Chain Issues will be addressed, since Dealer requirement will be met from single location and company is also expecting increase in Dealer order value and frequency.

This milestone marks a crucial step in our growth strategy, further strengthening our manufacturing capabilities and ensuring a steady supply of high-demand products.
