Dear Sir/Madam,

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we wish to inform you that Goyal Salt Limited ("the Company") continues to make steady progress in line with its strategic expansion and growth objectives. The Company's new manufacturing facility situated at Gandhidham became fully operational on 30th September 2025, achieving optimum production capacity of 1500 Metric Tons per day in double shift operation. During the half year ended 30th September 2025, the Company also launched a new product, "Goyal Gold", which has received an overwhelming response from customers and distributors across markets.

In continuation of our growth strategy and to cater to the increasing demand, the Company has proposed to set up a new manufacturing plant at Bharuch, Gujarat, with an estimated production capacity of 700 Metric Tons per day. The proposed plant will be located approximately 500 kms from the existing facility in Gandhidham, Gujarat. This will help the company to cater the Central and Southern India markets. Further Expansion Project at Bharuch, Gujarat has been noted and approved by the Board in their meeting held on Friday, November 07th, 2025 and it was commenced at 1:30 p.m. and concluded at 2:10 p.m.

To strengthen its market presence, the Company also plans to expand its distribution network by appointing one distributor in every district across India, thereby enhancing its footprint in the B2C segment. The Company continues to strengthen its established B2B operations as the Company has recently secured an order worth ₹78.36 crores from the Chhattisgarh Government, as previously communicated via our earlier intimation dated October 20, 2025. These developments reflect the Company's consistent efforts to achieve sustainable growth and deliver enhanced value to all stakeholders.

The company is aiming to become a dominant player in the salt Industry by foraying in the B2C sales. The company also wants to export its salts to overseas market in big way. At present our Salt Refineries and Washery at Nawa, Rajasthan has production capacity of 900 MT per day and

Salt Refineries at Gandhidham, Gujarat has production capacity of 1500 MT per day which is not sufficient to meet the retail and export market demands. Hence, we intend to increase the production capacity by setting up another refinery of 700 MT in the State of Gujarat near Bharuch.

With this expansion, our future production capacity is likely to be increased to 3100 MT per day. With this enhanced capacity we will be one of the largest players in Salt industry in India and with this enhanced capacity we will be able to cater the retail demand and ever-growing export market demand.

Further with refineries in both the locations where raw salts is produced in India namely Rajasthan and Gujrat, we will also be able to tap the Southern and Central India.

The company aims to sell the major production of Bharuch, Gujrat refinery in small packing of 1kg, ½ Kg, 200 gms, 50 gms and 10 gms in the form of table salts etc.
