Sub: Approval of our Company's Steel Billets by Power Grid Corporation of India Ltd for manufacture of Galvanized Fabricated Steel Structures

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, we are pleased to inform you that the Steel Billets (HT Billets conforming to IS 14650) manufactured by our Company have been approved by Power Grid Corporation of India Limited (PGCIL) vide its manufacturer approval letter dated 02.07.2025 for a validity period up to 01.07.2026. Our Company Steel Billets (IS 14650 CPS 2062/E250A as per 14650) were already approved by PGCIL vide its letter dated 05.02.2025 which was informed to the stock exchanges vide letter dated 06.02.2025.

As a result of this approval, our Company has become eligible to supply entire range of HT Steel Billets to all manufacturers of Galvanized Steel Structures for the transmission projects of PGCIL. This development demonstrates the quality products made by the Company and similar to the quality of steel billets made by large steel players in India.

We would also like to mention that our Company is already manufacturing Galvanized Fabricated Steel Structure, however, in view of non-availability of steel billets GPIL was not able to offer entire range of Galvanized Steel Structures to the Contractors of PGCIL, as the cost was very high for Galvanized Structures manufactured from HT billets purchased from market. Now with the approval of HT Billets of the Company by PGCIL, the Company will be able to offer entire range Galvanized Steel Structures, which is expected to increase business volumes and profitability. It is also pertinent to mentioned that GPIL is the only Company in India to manufacture Galvanized Steel Structures from iron ore to finished product.
