**Sub: Allotment of 13,72,500 Equity Shares of Re 1/- each consequent upon conversion of Warrants.**

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and our earlier disclosure dated 14.11.2025 wherein we informed you that the Company had allotted 2,04,08,220 convertible warrants to Promoter, members of the Promoter Group of the Company and other identified Non Promoters by way of preferential issue on a private placement basis.

The issue price of the warrants was Rs. 245/- per warrant, out of which Rs. 61.25 per warrant (being 25% of the issue price) was received as the initial subscription amount at the time of allotment of the warrants.
