Seen On Cam: Red Fort Bomber At India Gate And Kartavya Path

Police Scan Footage From Over 1,300 CCTVs To Create Umar's Electronic Route

New Delhi: After scanning the footage of over 1,300 CCTV cameras across Delhi-NCR and beyond, investigators probing the blast near Red Fort last Monday have prepared an "electronic route" taken by the bomber, Umar N Nabi, in his i20.

It maps his movements from Oct 29—beginning at Al Falah University in Faridabad to Delhi-Mumbai Expressway, then to Nuh and back, before finally entering Delhi on the morning of Nov 10, hours before an explosion was triggered in the car.

CCTV cameras captured the car around vital and sensitive locations, including Kartavya Path and India Gate, apart from around three dozen other places. Umar, who was driving the car, wasn't stopped at any checkpoint.

The first footage reveals the i20 entering the university campus on Oct 29—Umar was a professor of medicine there—before stopping at a common parking space at 6.36pm and then outside a hostel at 8.18pm.

At 7.31am on Oct 30, the car was back at the parking. By 2.38pm, Umar had called a mechanic and a compounder. Three minutes later, the car left the university premises.

Intelligence agencies have questioned the mechanic.



Umar then went to Nuh and stayed put at a rented accommodation for the next one week, assembling IDs using DIY videos sent to him by his handlers from Turkey and Afghanistan, according to people familiar with the probe.

The i20 re-emerged on Nov 9. Cameras captured it near Khalilpur toll plaza on Delhi-Mumbai Expressway at 11.43 pm. Early on Nov 10—the day of the blast—it was seen near Kundli-Manesar-Palwal Expressway, and then at several locations of Delhi like Badarpur, Mayur Vihar and the DND.

Between 9.17am and 9.48 am, the car was driven past multiple central Delhi areas, including Nizamuddin, India Gate, Akbar Road, Rail Bhavan, Kartavya Path, Lodhi Road and Safdarjung Hospital. In between, Umar stopped at a tea shop in Wazirpur.

The car later crossed Connaught Place's outer circle at 2.04 pm, Barakhamba Road at 2.10 pm, was seen near Ramleela Maidan at 2.17pm and Turkman Gate Masjid at 2.34 pm. It reached Delhi Gate at 3.15pm and crossed Dariba Ganj police station at 3.16 pm. Umar then parked it at a lot near Red Fort at 3.29pm. At 6.23 pm, the car exited the parking, and at 6.50pm, reached the spot where the blast would be triggered.

Notice to Al-Falah over UGC, NAAC claims; cops studying older FIRs against univ director

New Delhi: The crime branch of Delhi Police has asked Al-Falah University officials for clarification regarding its claims of National Assessment and Accreditation Council certification and University Grants Commission recognition.

Police sources said a team of cops visited the office of Al-Falah trust in Okhla Saturday and served a notice in the name of the university's vice-chancellor, seeking documents

and explanations regarding its "accreditation" and details under Section 12(B) of UGC Act.

"They were asked to submit the documents at the earliest, after which police will examine the papers, and may summon individuals as and when required for the investigation," the sources said.

The crime branch is set to question university officials in connection with FIRs filed against it for



"forgery and cheating". The cops are reportedly studying older FIRs against the university's director, Jawad Ahmad Siddiqui.

On Saturday, NAAC had served a notice to the university, which says: "Al-Falah... which is neither accred-

ited nor applied for accreditation by NAAC, has publicly displayed on its website that it is an endeavour of Al-Falah Charitable Trust, which has been running three colleges on the campus, namely Al-Falah School of Engineering and Technology (since 1997, Graded A by NAAC), Brown Hill College of Engineering and Technology (since 2008), and Al-Falah School of Education and Training, Graded A by NAAC." Forest dept set to restore Ennore creek with 20K mangrove saplings

Chennai: The Forest department's plan to restore Ennore Creek with a massive mangrove plantation is underway. Once marred by industrial pollution and an oil spill, Chennai's Ennore Creek is now showing early signs of recovery as the Tiruvallur district forest department begins restoring the estuary with 20,000 mangrove saplings planted using an innovative fishbone technique.

The fishbone model involves carving channels that allow seawater to flow naturally into the area during high tides, creating ideal conditions for mangroves to thrive. This year's restoration drive spans 15 hectares, including 4 hectares under this new model. The department's renewed commitment builds on last year's success when 1.8 lakh



saplings of Avicennia marina, Rhizophora mucronata, and Excoecaria agallocha were planted.

This season, three additional species—Aegiceras corniculatum, Ceriops decandra, and Acanthus—have been introduced to increase biodiversity. According to state forest secretary Supriya Sahu, the creek's year-round water availability will ensure stronger survival rates for the young plants. Over 1 lakh more saplings are being raised and will be planted by January. To make space for this renewed growth, the department has cleared 250 hectares of

invasive Prosopis juliflora, which once choked native vegetation.

Tiruvallur district forest officer V Subbiah said 1.05 lakh saplings were raised in the department's central nursery at Kattuppalli village, including 45,000 Avicennia and 55,000 Rhizophora saplings. Ecologist J Murali said the saplings will take a couple of years to get well-established in the creek. Once they are established, algae and zooplankton will settle in that area. This, in turn, will attract fish species and also prawns.

Once the fish and prawn population bounces back in the area, it will help the local fishers to increase their livelihood opportunities. Besides that, the area will attract both resident and migratory birds, which will make the mangrove area their feeding, nesting, and roosting ground, he said.

Kerala SEC norms for AI use for fake images, audio messages and false info

Kochi: State election commissioner A Shajahan announced that strict monitoring would be done for local body election campaigns using artificial intelligence (AI). Strict actions will be taken against the creation and use of fake images, audio messages and false information through modern technology in poll campaigns, he said.

Shajahan said candidates, political parties and campaigners should adhere to the guidelines to ensure credibility of the campaigns and fairness in competition.

There is a high likelihood of technology misuse during elections and so state election commission (SEC) issued guidelines. SEC assessed that deepfakes and artificially-created content used in campaigns could mislead public opinion and
