**Sub: Disclosure under Regulation 30 of the SEBI [Listing Obligations and Disclosure Requirements] Regulations, 2015**

Further to our intimation dated June 28, 2024 with regard to certain fines levied by BSE Limited and National Stock Exchange of India Limited, for alleged non-compliances under Regulation 17 (1A) of SEBI (LODR) Regulations, 2015, the application submitted by the Company to the Designated Stock Exchange i.e BSE Limited as per SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 requesting the waiver of said fines was rejected by the Internal Regulatory Oversight and Review Group (IRORG) of BSE Limited and communicated vide their email dated April 30, 2026. The Company had made the aforesaid application in good faith and not on account of any deliberate or material non-compliance.

The company has already deposited the fine amount with the stock exchanges under protest while making the waiver application and accordingly there is no financial impact arising from this decision. The details of payments made are given under:
