पाण्याला बॅक्टेरिया आणि अनेक हानिकारक घटक नष्ट करण्याचा एक प्रभावी मार्ग मानला जातो. पाणी १-३ मिनिटे उकळले की बहुतेक जंतू आणि विषाणू मरतात, ज्यामुळे पाणी पिण्यासाठी योग्य बनते. तथापि, उकळल्याने सर्व बॅक्टेरिया पूर्णपणे नष्ट होतात असे म्हणणे पूर्णपणे बरोबर नाही. काही बॅक्टेरियांचे बीजाणू आणि रासायनिक दूषित पदार्थ उकळवून काढून टाकले जात नाहीत. उकळलेले पाणी स्वच्छ भांड्यात योग्यरित्या साठवणे देखील महत्वाचे आहे, कारण जर ते पुन्हा दूषित झाले तर त्याचे फायदे नष्ट होतात. म्हणून, उकळत्या पाण्यासोबतच, पाणीपुरवठा आणि साठवणुकीच्या स्वच्छतेकडे



देखील लक्ष दिले पाहिजे. या गोष्टी लक्षात ठेवा. पाणी कमीत कमी १-३ मिनिटे उकळा. उकळलेले पाणी झाकून स्वच्छ भांड्यात ठेवा. पाणी उकळण्यापूर्वी गाळून घ्या जेणेकरून त्यातील कोणतीही अशुद्धता काढून टाकता येईल. शक्य असल्यास, पाणी गाळून पुन्हा उकळा. साठवणुकीचे भांडे वेळोवेळी स्वच्छ करा. जास्त वेळ साठवलेले उकळलेले पाणी पिणे टाळा. जर पाणीपुरवठा खूप प्रदूषित असेल तर उकळण्याव्यतिरिक्त योग्य गाळण्याची प्रक्रिया वापरा.

ठेवते आणि शरीराचे तापमान नियंत्रित करते. स्वच्छ पाणी पिल्याने मूत्रपिंडांचे कार्य योग्यरित्या होण्यास मदत होते आणि मूत्रमार्गाच्या संसर्गासारख्या समस्यांचा धोका कमी होतो. याशिवाय, ते उर्जेची पातळी राखते, ज्यामुळे दैनंदिन कामात मदत होते. जेव्हा शरीराला बॅक्टेरियामुक्त पाणी मिळते तेव्हा रोगप्रतिकारक शक्ती मजबूत राहते आणि रोग टाळाटा लोकांमध्ये त्याचा परिणाम आणखी धोकादायक असू शकतो. म्हणून, आरोग्य राखण्यासाठी स्वच्छ आणि सुरक्षित पाणी पिणे खूप महत्वाचे आहे.
