ABOUT ESPRIT STONES LIMITED...

Esprit Stones Limited was incorporated in 2016, arising from a legacy of over 40 years in the business of high-quality natural stone surfaces. The Company is a synergy between two prominent business houses of Udaipur, Rajasthan — the Aravali Group, with a diversified presence across mining, real estate and finance since 1975, and the Gattani Group, a multi-faceted conglomerate with interests spanning hospitality, infrastructure, distribution, energy and FMCG since 1979 — brought together to explore new frontiers and set new benchmarks in the engineered stones business.

Within a short span of five years of becoming operational (2017-2022), the Company scaled its manufacturing capacity and diversified its product portfolio significantly. Commencing operations in 2017 with a single press line and polish line producing approximately 24 lakh sq. ft. of engineered quartz per annum, the Company's quartz manufacturing facility today operates three pressing lines and two polishing lines, with an annual production capacity of approximately 72 lakh sq. ft. The Company also commissioned a facility for manufacturing quartz grit and quartz powder, the primary raw material used in engineered quartz production, strengthening its backward integration and control over raw material quality. In 2022, through its subsidiary Haique Stones Private Limited (HSPL), the Company commenced manufacturing and processing of engineered marble surfaces, equipped with one pressing line, two gangsaws, and one polishing line, with an annual capacity of approximately 74 lakh sq. ft.

In February 2024, the Company converted into a Public Limited Company, and in August 2024, it got listed on the SME Platform of NSE-EMERGE. Today, Esprit Stones is recognized as one of the key players in the engineered stones industry in India (Source: CARE Report). The Company's quartz surfaces are non-porous, and resistant to staining, heat and scratches, making them well suited for kitchen countertops, bathrooms, flooring, wall cladding and furniture applications, and are crafted using high-quality minerals sourced from the mineral-rich region of Southern Rajasthan. The Company markets and sells its products across domestic and international markets through a combination of direct export sales and an established network of independent distributors. As on the date of this Annual Report, the Company exports to over 10 countries, including the USA, Canada, Egypt, Bulgaria, UAE, and Saudi Arabia, under white labelling arrangements.

While the Company's business was initially export-oriented, it launched its premium brand 'Haique' (originally 'Haiqu') to capitalize on the growing demand for engineered stones in the domestic market. Positioned as the world's first fashion-inspired brand for luxury surfaces, Haique draws its design language from global fashion capitals — Paris, Milan, New York, London, Tokyo and Rome — across its quartz, neo-marble, terrazzo and semi-precious stone collections. As on the date of this Annual Report, the Company has extended its distribution reach to 15 states across the country, and has set up an experience centre at Kishangarh, Rajasthan — India's marble city — along with a storage facility and sales office in Mumbai, Maharashtra.

The Company's business strategy remains centred on continuously strengthening its product portfolio through sustained investment in product innovation, research and development, focused marketing initiatives, and long-term customer relationships. During the year, the Company also launched a distinctive marketing initiative in strategic collaboration with architects and interior designers, redefining luxury as "Maison Fashion." Going forward, the Company remains committed to developing engineered stones with innovative colours, designs, textures and thicknesses, while expanding applications into high-end bathroom surfaces, countertops, and wall cladding — reinforcing 'Haique's position as a leading premium engineered stone brand.

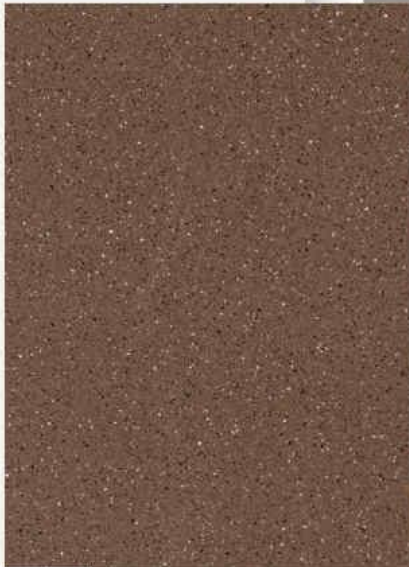

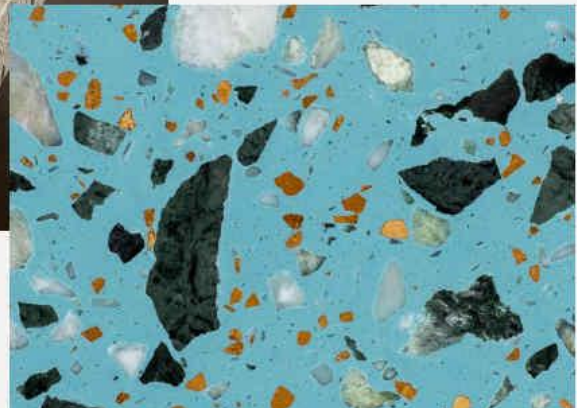

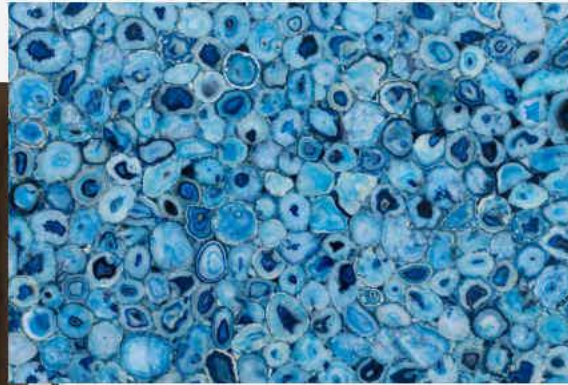

MANAGEMENT COMMUNIQUE

Dear Shareholders,

We are pleased to present the 10th Annual Report of Esprit Stones Limited for FY 2025-26, marking a decade of your Company's journey since inception. This milestone year has tested our resilience amidst a challenging global trade environment, and while the year under review presented certain headwinds, it has also reaffirmed the strength of our operating model and our commitment to building a more diversified and future-ready organization.

Economic Overview

The global macroeconomic environment in FY 2025-26 continued to be shaped by trade-related uncertainties, tariff actions, and shifting geopolitical alignments, particularly impacting export-oriented sectors with significant exposure to the United States market. India, however, continued to demonstrate underlying resilience, supported by steady domestic demand, infrastructure spending, and industrial expansion.

Within this backdrop, the quartz and engineered stone manufacturing industry faced a more demanding operating environment. Heightened tariff measures on exports to the USA, coupled with volatility in raw material and logistics costs, weighed on the sector's performance. At the same time, opportunities continued to emerge from rising urbanization, growing preference for durable and aesthetic surfacing materials, and expanding demand in non-USA international markets and the domestic market. Going forward, market diversification, cost discipline, and value-added product innovation will remain critical to the industry's long-term growth trajectory

Performance Overview

FY 2025-26 was a challenging year on the financial front. On a consolidated basis, revenue from operations declined to INR 172.53 crores from INR 321.48 crores in the previous year, a decline of approximately 46%, primarily on account of a decline in export revenues, significant concentration risk arising from the Company's dependence on the United States market amid escalating tariffs, and the disposal of one of its subsidiaries, Addwaya Chemicals Private Limited, during the year. Consequently, operating profit declined to ₹5.73 crores from ₹37.12 crores, with operating margins reduced from 11.55% to 3.32% in current year, and the Company recorded a net loss of ₹3.86 crores for the year, as against a net profit of ₹17.20 crores in FY 2024-25

Notwithstanding these challenges, the management responded with reasonable and proactive steps to address the underlying issues. We accelerated efforts to diversify our revenue base by strengthening our presence in the domestic market and expanding our footprint in non-USA geographies, including the UAE and other international markets. These initiatives reflect our commitment to reducing over-reliance on any single market and building a more balanced, resilient business model. Our team of 300+ individuals continued to be the backbone of this execution effort, adapting swiftly to the evolving environment while staying aligned with our long-term objectives.

Disposal of Subsidiary – Addwaya Chemicals Private Limited

During the year under review, the Company divested its entire 51% shareholding in Addwaya Chemicals Private Limited ('the erstwhile subsidiary'), engaged in polyester resin manufacturing. As, In March 2025, the erstwhile subsidiary had received a closure directive from the Regional Office of the Rajasthan State Pollution Control Board in respect of its manufacturing facility in District Rajsamand, Rajasthan, under the applicable provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981. Following an evaluation of the situation, the Company divested its entire 51% stake in the erstwhile subsidiary on September 30, 2025, for a consideration of ₹120.87 lakhs, based on a valuation duly certified by a registered valuer. The transaction resulted in a net gain on disposal of ₹52.49 lakhs, which has been disclosed as an exceptional item in the consolidated financial statements. This decision reflects the Company's disciplined approach to portfolio management and its focus on core, high-growth business segments.

Staring At Robust Growth Opportunity

The global engineered stone industry is expected to grow at a 6% CAGR between 2027 and 2032, reaching US\$ 48,104 million by 2032, with engineered quartz remaining the major contributor within the segment. The Indian engineered stone market, valued at approximately \$3,643 million in 2022, is projected to grow at a CAGR of 7-8% between 2022 and 2027, and is expected to reach \$7,355 million by 2032.

Despite a challenging year, Esprit's competitive position, established client relationships, and execution capabilities place the Company well to capitalize on this long-term growth opportunity as global trade conditions normalize and our diversification strategy gains further traction

Fulfilling Our Commitments Towards Environment, Society and Governance

At Esprit, we remain committed to a holistic approach that integrates environmental and social considerations into our strategy, decision-making, and day-to-day operations. Even as the Company navigated a demanding year, our focus on responsible business conduct, strong governance, and sustainable practices remained undiminished, reinforcing our commitment to long-term value creation for all stakeholders.

Looking Ahead

As we complete a decade of operations, Esprit Stones Limited remains focused on translating the lessons of FY 2025-26 into a stronger, more diversified business. Our priorities going forward include deepening our presence in the domestic market, expanding further into non-USA export geographies, enhancing operational efficiency, and maintaining disciplined capital allocation. Further, the Company has decided for increasing its production capacity for Engineered Quartz Surfaces enabling it to manufacture high-end and trending quartz surfaces.

We remain cautiously optimistic about our ability to navigate the evolving global trade environment and return to a sustainable growth trajectory, and we thank our shareholders, customers, employees, bankers, and other stakeholders for their continued trust and support as we build the next decade of Esprit Stones Limited.

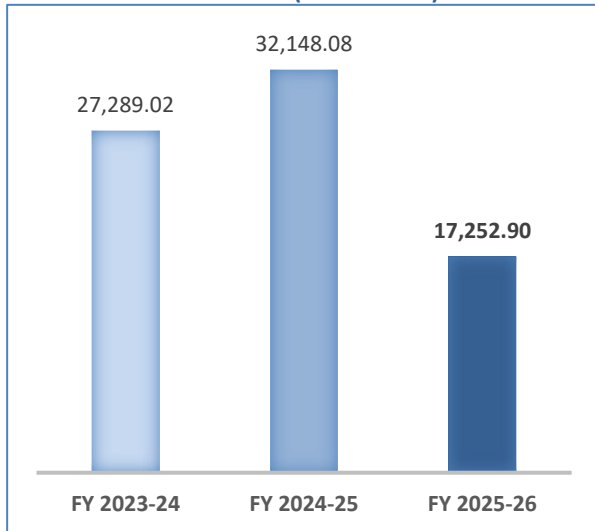

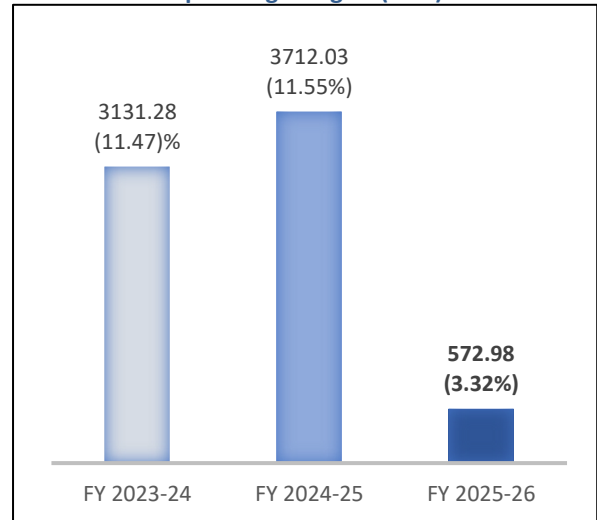

Revenue (in INR lakhs)



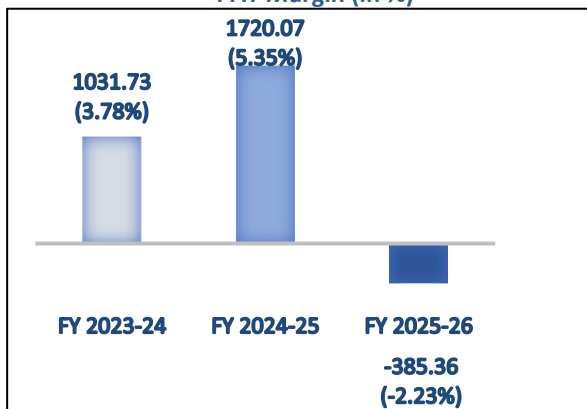
Operating profits (in INR lakhs)

Operating Margins (in %)

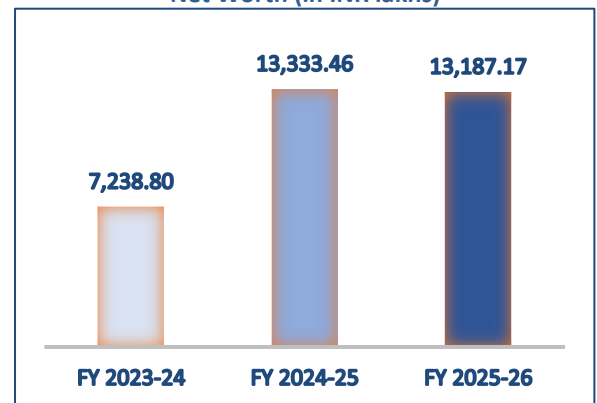


PAT (in INR lakhs)

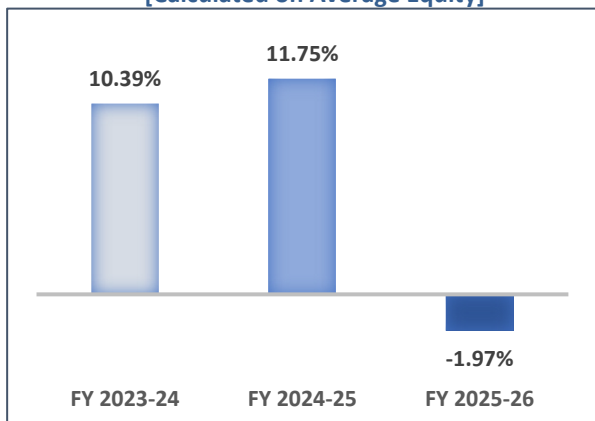
PAT Margin (in %)



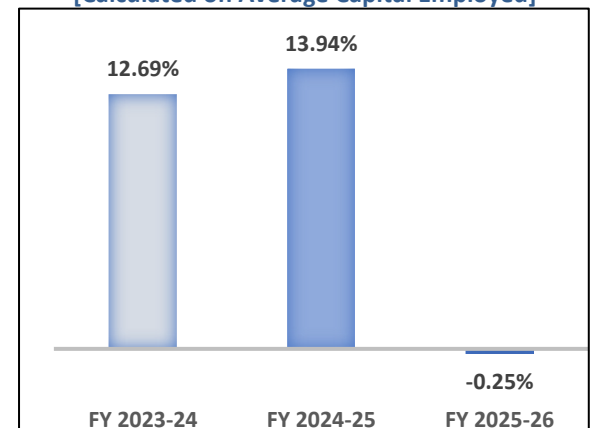
Net Worth (in INR lakhs)

ITEM NO. 3: TO RE-APPOINT M/S. A BAFNA & CO, CHARTERED ACCOUNTANTS (FIRM REGISTRATION NO. 003660C) AS STATUTORY AUDITORS OF THE COMPANY TO HOLD OFFICE FOR A PERIOD OF FIVE CONSECUTIVE FINANCIAL YEARS (I.E. FROM 2026-27 TO 2030-31) OF THE COMPANY.

M/s. A Bafna & Co, (Firm Registration Number: 003660C), Chartered Accountants, hold the office of statutory auditors in first term of five consecutive years, as per the members' approval accorded at the 05th Annual General Meeting (AGM) held on November 30, 2021 till the conclusion of the 10th Annual General Meeting of the Company. Secondly, the Company's subsidiary, Addwaya Chemicals Private Limited, incurred losses during the first half of the year, which were consequently consolidated into the Company's financial results for the said period in accordance with applicable accounting standards. The Company subsequently divested its shareholding in the said subsidiary during the year as on **30th September, 2025** which it ceased to be a subsidiary of the Company and its results were no longer consolidated.

The cumulative impact of the aforesaid factors resulted in the loss reported at the consolidated level for the year under review. The Company continues to take necessary steps to strengthen its operations and improve profitability going forward.

Standalone

During the financial year 2025-26, on a standalone basis, the Company's revenue from operations decreased by 34.64% to Rs. 12,603.59 Lakhs, as compared to Rs. 19,283.24 Lakhs in the previous financial year 2024-25.

The Company reported a net loss of Rs. 481.07 Lakhs during the financial year 2025-26 as against a net profit of Rs. 836.19 Lakhs in the previous financial year 2024-25. The decline in financial performance was primarily attributable to lower sales volume of quarts surfaces being exported to the USA due to increased tariffs.

During the financial year under review, on a consolidated basis, the Company's revenue from operations decreased by 46.33% to Rs. 17,252.90 Lakhs, as compared to Rs. 32,148.08 Lakhs in the previous financial year 2024-25. The Company reported a consolidated net loss of Rs. 385.36 Lakhs for the financial year 2025-26 as against a consolidated net profit of Rs. 1,720.07 Lakhs in the previous financial year 2024-25.

It is also involved in manufacturing of raw materials such as quartz grit and unsaturated polyester resin for engineered stones. It also sale Unsaturated Polyester Resin in the open market through its subsidiary, however effective September 30, 2025 Addwaya Chemicals Private Limited ceased to be a subsidiary of the Company. Accordingly, during the current year the Company's revenue is pre-dominantly from only one segment i.e. Engineered Stones.

3. DIVIDEND AND RESERVES:

After considering the financial results for the financial year 2025-26, your directors are of the opinion that it is prudent that no dividend be declared for the year under review. The Company does not propose to transfer any amount to reserves.

4. MANAGEMENT'S DISCUSSION AND ANALYSIS REPORT:

Management's Discussion and Analysis Report for the year under review, in terms of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations"), is presented in a separate section forming part of the Annual Report.

The Company had duly intimated the Stock Exchange regarding the said transaction.

MANAGEMENT DISCUSSION & ANALYSIS

ECONOMIC OVERVIEW

Global Economy

The global economy remained resilient during FY 2025-26 (April 2025 to March 2026) amid geopolitical tensions, evolving trade policies, supply-chain disruptions and financial-market volatility. Global growth remained moderate. On a calendar-year basis, the IMF projected global growth of 3.1% in 2026 and 3.2% in 2027. Inflationary pressures have generally eased, although risks from geopolitical developments, commodity prices and changing trade policies remain. The global environment continues to underscore the importance of market diversification, supply-chain resilience, cost efficiency and prudent financial management for globally integrated businesses.

Global Economic Outlook

The global economic outlook remains one of moderate growth accompanied by elevated uncertainty. The IMF expects global inflation to resume its declining trajectory in 2027, although risks remain around geopolitical escalation, commodity-price movements, trade restrictions and financial-market conditions. At the same time, structural themes such as technological advancement, infrastructure investment, supply-chain diversification and the reconfiguration of global manufacturing are expected to create new opportunities across emerging markets. Businesses with diversified geographical exposure, competitive manufacturing capabilities and the ability to adapt their product and market mix are relatively better positioned to navigate this environment.

Indian Economy

India continued to remain one of the fastest-growing major economies during FY 2025-26 (April 2025 to March 2026), supported by domestic consumption, investment, infrastructure development and improving economic fundamentals. The Economic Survey 2025-26 estimated real GDP growth at 7.4% for FY 2025-26 and indicated a medium-term potential growth rate of approximately 7.0%. Continued public investment in infrastructure, expanding manufacturing capabilities, formalisation of economic activity and digitalisation remained important drivers of growth. India's growing integration with global value chains is creating opportunities for export-oriented manufacturing, while strong domestic demand provides a broad base for economic activity. However, the external environment remains a key consideration, with global trade policies, geopolitical developments, commodity prices and financial-market conditions influencing exports, input costs and currency movements. In this environment, competitiveness, diversification and resilience remain important for sustaining India's growth momentum.

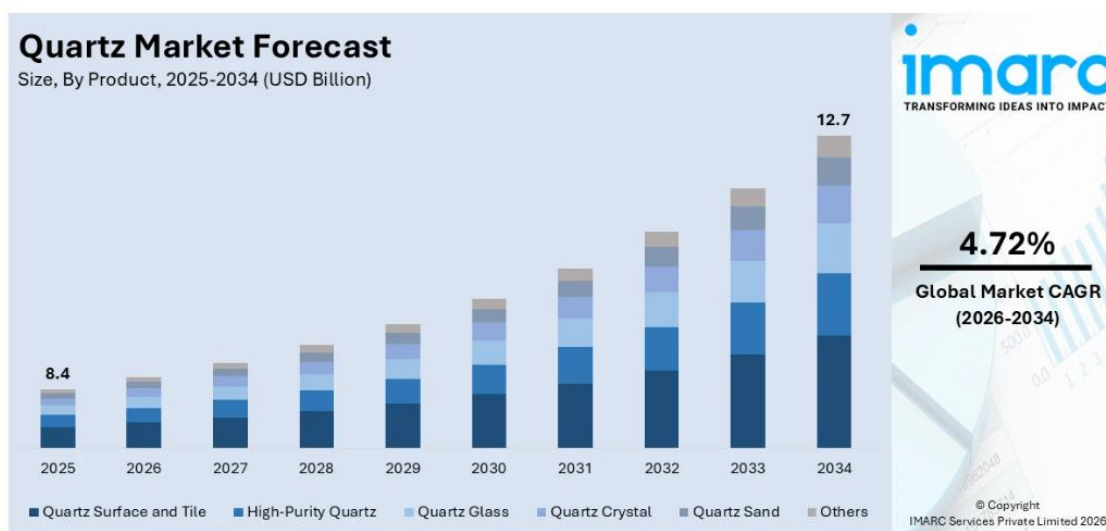
Indian Economic Outlook

India's medium-term economic outlook remains constructive, supported by strong domestic demand, infrastructure-led growth, investment, favourable demographics and continuing policy support for manufacturing and economic formalisation. The Economic Survey's assessment of approximately 7% medium-term potential growth provides a favourable backdrop for businesses operating in manufacturing and construction-linked sectors. For the domestic building-materials and surfaces industry, sustained urbanisation, residential and commercial construction, infrastructure development and increasing consumer preference for premium and engineered surfaces are expected to support long-term demand. At the same time, companies will need to remain focused on productivity, product differentiation, cost competitiveness, efficient working-capital management and evolving customer preferences.

INDUSTRIAL OVERVIEW

Engineered Stone Surfaces

Engineered stone surfaces constitute a growing segment of the global surfaces and building materials industry, comprising engineered quartz, composite marble, terrazzo and other engineered stone products. These products are used across residential, commercial and hospitality applications, including kitchen countertops, vanity tops, flooring, wall cladding and other interior surfaces. The industry continues to benefit from urbanisation, residential and commercial construction, renovation and remodelling, and increasing preference for durable, aesthetically versatile and low-maintenance surface solutions. Advancements in manufacturing and surface-finishing technologies have further expanded the range of designs, colours, textures and finishes available to consumers and design professionals.



Indian Industry

India has established itself as an important manufacturing and exporting base for engineered stone surfaces, supported by its mineral resource availability, established stone-processing ecosystem, manufacturing capabilities and skilled workforce. The domestic market is also witnessing increasing adoption of engineered surfaces, driven by urbanisation, premiumisation of residential and commercial interiors and growth in organised construction. The industry has a significant international orientation, with demand influenced by construction and renovation activity in key global markets. Accordingly, manufacturers remain exposed to global economic conditions, trade policies and tariffs, freight costs, raw-material prices, currency movements and competitive intensity.

Industry Outlook

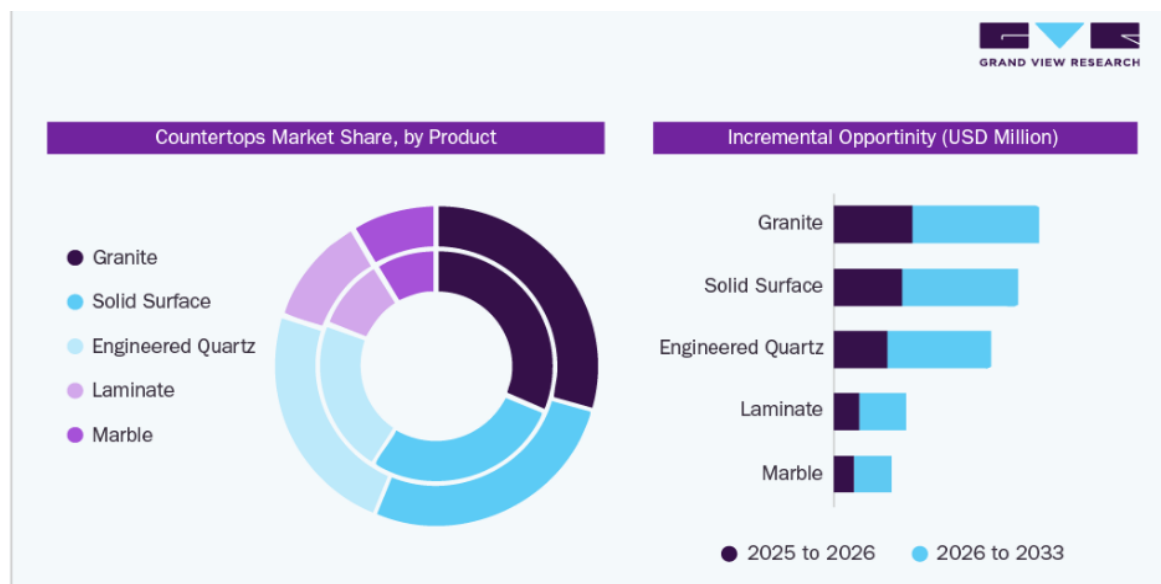
The long-term outlook for engineered stone surfaces remains favourable, supported by continued urbanisation, construction and renovation activity, premiumisation and increasing adoption of engineered surfaces across applications. India's manufacturing and export capabilities provide a strong platform for participation in global markets. Going forward, product innovation, portfolio diversification, manufacturing efficiency, quality consistency and geographic diversification are expected to remain key competitive priorities as the industry responds to evolving customer preferences and changing global trade dynamics.

GROWTH FOR ENGINEERED STONES MARKET – GLOBALLY & INDIA

The global engineered stone surfaces industry presents a compelling long-term growth opportunity, supported by sustained urbanisation, residential and commercial construction, renovation and remodelling, and increasing preference for durable, aesthetically appealing and low-maintenance surface solutions. The global engineered stone market was estimated at approximately USD 26.5 billion in 2025 and is projected to reach USD 45.2 billion by 2033, representing a CAGR of approximately 7.1%. More recent industry estimates place the market at approximately USD 29.0 billion in 2025, with a projected CAGR of 7.9% through 2032, reinforcing the expectation of sustained mid-to-high single-digit growth over the medium term.

Importantly, the opportunity extends well beyond traditional kitchen applications. Countertops currently constitute the largest application, accounting for approximately 79.7% of global engineered stone market revenue in 2025, with this segment itself projected to grow at approximately 7.3% CAGR through 2033. Engineered surfaces are also gaining acceptance across bathroom and vanity tops, flooring, wall cladding, façades, hospitality, commercial interiors and other architectural applications. The global engineered stone flooring segment is estimated to grow at approximately 5.6% CAGR, while engineered stone tiles are projected to grow at approximately 6.3% CAGR, indicating increasing scope for application and product diversification.

Against this backdrop, the Company believes that the evolution of the surfaces industry from a predominantly functional category towards a design-led, application-driven and premium interior solution creates significant opportunities for sustained growth. India's established manufacturing ecosystem, availability of key mineral resources, skilled processing capabilities and growing acceptance of engineered surfaces provide a strong foundation for Indian manufacturers to participate in global demand. The Company's diversified portfolio comprising engineered quartz, composite marble and terrazzo surfaces, coupled with its international market presence, positions it to address a broader range of customer requirements and applications. Going forward, the Company intends to leverage these structural growth opportunities through portfolio expansion, design and product innovation, deeper penetration across existing and new geographies, development of application-led solutions, strengthening of domestic market presence and continuous improvement in manufacturing productivity and cost competitiveness. The Company's focus will remain on building a more diversified and resilient business, with growth increasingly driven by product value, customer relationships, application expansion and geographic reach rather than dependence on any single product or market.



RISK MANAGEMENT

The engineered stone surfaces industry offers attractive long-term growth prospects; however, its global and export-oriented nature exposes industry participants to evolving trade policies, raw-material and logistics volatility, intense competition, regulatory developments and changing customer preferences. The Company recognises these risks and continues to strengthen its business model through product diversification, geographic expansion, operational efficiency and disciplined risk management.

Trade Policy and Market Access: Changes in tariffs, duties, trade remedies and import regulations in key export markets can materially influence landed costs and competitiveness. The evolving trade environment for quartz surface products in the United States highlights the importance of market diversification. The Company is therefore focused on broadening its geographic footprint, developing multiple export markets and strengthening domestic market penetration, thereby reducing dependence on any single geography and improving resilience to market-specific trade measures.

Raw Material, Energy and Logistics Volatility: Fluctuations in the prices and availability of minerals, resins, pigments, energy, packaging materials and freight can impact manufacturing costs and margins. The Company seeks to mitigate these risks through supplier diversification, procurement planning, inventory optimisation, manufacturing efficiencies and continuous cost management. Wherever market conditions permit, pricing and product-mix management are used to partially offset input-cost pressures.

Competitive Intensity and Pricing Pressure: The industry remains competitive, with manufacturers competing on design, quality, product consistency, delivery capabilities and price. Alternative materials such as natural stone, porcelain and sintered surfaces further expand the competitive landscape. The Company is addressing this through continuous product and design development, portfolio diversification across engineered quartz, composite marble and terrazzo, quality enhancement and greater focus on differentiated and value-added products, rather than relying solely on price-based competition.

Silica-related Health and Regulatory Developments: Increasing regulatory and customer focus on occupational exposure to respirable crystalline silica, particularly during fabrication of high-silica quartz surfaces, represents an evolving industry challenge. The Company recognises the importance of responsible manufacturing and downstream safety practices and continues to emphasise appropriate workplace controls, dust-management systems, employee awareness, safe operating procedures and compliance with applicable health and safety requirements. Product and portfolio diversification also provides the flexibility to respond to evolving regulatory and market requirements.

Changing Consumer Preferences and Substitution Risk: Rapid innovation in surface materials can alter customer preferences and create competition from newer technologies and materials. The Company therefore continues to focus on design innovation, product development, application-specific solutions and market feedback, enabling it to respond to evolving architectural and interior-design trends.

Overall, the Company's mitigation approach is centred on building a diversified, efficient and adaptable business model. Product and application diversification, wider geographic reach, operational excellence, prudent procurement and working-capital management, quality consistency and continuous innovation are expected to remain key pillars of the Company's strategy for managing industry risks while capturing the underlying growth opportunity in engineered stone surfaces.

COMPANY OVERVIEW

Esprit Stones Limited (“ESL” or “the Company”) is a professionally managed manufacturer and exporter of engineered stone surfaces, with a product portfolio comprising engineered quartz, composite marble and terrazzo surfaces. The Company is engaged in manufacturing surface solutions designed for a range of residential, commercial and architectural applications, including countertops, vanity tops, flooring, wall applications and interior spaces.

With a manufacturing-led business model and an international market orientation, ESL serves customers across domestic and overseas markets. The Company's capabilities encompass key stages of engineered-surface manufacturing, including raw-material preparation, mixing, pressing and vacuum vibro-compression, curing, calibration, polishing, inspection and finishing. The Company continues to focus on product quality, design development, manufacturing efficiency and customer responsiveness as key elements of its competitive positioning.

ESL is focused on building a diversified and scalable engineered surfaces business by expanding its product and application portfolio, strengthening its presence across domestic and international markets and improving operational efficiency. The Company's strategy is centred on leveraging the long-term growth potential of engineered surfaces while developing a more resilient business model through product diversification, geographic expansion, innovation, cost competitiveness and disciplined financial management.

The Company is progressing towards capacity expansion planned for 2027, with the proposed facility being designed around advanced manufacturing technology for engineered quartz surfaces. The new-generation technology is expected to enhance production capabilities, improve process precision and consistency, enable a broader range of contemporary designs and finishes, and strengthen overall manufacturing efficiency. The expansion is intended to provide the Company with additional capacity to address the anticipated growth in domestic and international demand, while creating greater flexibility in product development and application-specific offerings. The investment represents an important step in strengthening the Company's long-term manufacturing platform and positioning it to participate more effectively in the evolving engineered surfaces market.

During March 2025, Addwaya Chemicals Private Limited (“Addwaya”), the erstwhile subsidiary in which the Company held a 51% stake, received a direction from the Regional Office of the Rajasthan State Pollution Control Board (RSPCB), Rajsamand, for closure of its manufacturing operations under Section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and Section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981. While the management of Addwaya was exploring the possibility of obtaining the requisite statutory permissions for recommencement of operations, the Company subsequently disposed of its entire 51% shareholding in Addwaya on September 30, 2025, for ₹120.87 lakh, based on the valuation certified by a registered valuer. The disposal was undertaken at the then prevailing fair value and resulted in a net gain of ₹52.49 lakh, recognised as an exceptional item in the Statement of Profit and Loss for the six months ended September 30, 2025.

The strategic decision represents an important step in sharpening the Company's business focus and aligning its portfolio towards its core engineered stone surfaces business. The disposal enables the Company to concentrate its managerial, financial and operational resources on its principal growth platform, while simplifying the Group's business structure and strengthening its focus on engineered quartz, composite marble and terrazzo surfaces. Following the transaction, the engineered surfaces business constitutes the Company's principal operating focus, providing a clearer platform for future capacity expansion, product development, market diversification and sustainable growth.

During FY 2025-26, the Group's consolidated revenue from operations stood at ₹172.53 crore, compared with ₹321.48 crore in FY 2024-25. The decline was primarily attributable to lower exports from the Engineered Stones business to the USA amid tariff-related uncertainties, together with the reduced contribution from the Unsaturated Polyester Resin business following its disposal during the year. The Engineered Stones segment recorded revenue of ₹170.40 crore, compared with ₹236.77 crore in the previous year, while the Resin segment contributed only ₹2.13 crore compared with ₹84.71 crore in FY 2024-25. Geographically, revenue from outside India stood at ₹112.51 crore, representing approximately 65% of total revenue, compared with ₹177.13 crore in the previous year, reflecting the continuing importance of international markets under the challenging US trade environment. These factors have resulted in Company's overall loss of INR ₹2.61 crore for the shareholders of the Company in FY 2025-26 against the profit of ₹15.66 crore earned during FY 24-25.

Report on the Audit of the Standalone Financial Statements

Opinion

We have audited the Standalone Financial Statements of **Esprit Stones Limited (Formerly Known as Esprit Stones Private Limited)**, which comprise the balance sheet as at 31st March 2026, and the statement of Profit and Loss, and statement of cash flows for the year then ended, and notes to the standalone financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March, 2026, and its loss and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter

We draw attention to the Note no 40, regarding the matter that during the year under audit of the standalone financial statements, the Company has disposed off its entire equity stake (51%) in Addwaya Chemicals Private Limited for a consideration of Rs. 120.87 lakhs resulting in the cessation of its status as a subsidiary with effect from 30th September 2025. These shares were acquired by Mr. Pranav Banthia and Mrs. Seema Banthia. The resultant profit/loss arising from such disposal has been duly recognized and accounted in the standalone financial statements of the Company for the period.

Subsequent to the disposal of its controlling interest, the Company continues to provide a corporate guarantee to the bank in respect of the said company's bank credit facilities which amounting Rs 742 Lakhs and also continues to hold an inter-corporate loan balance of Rs. 516.50 lakhs and interest amount to Rs 46.49 Lakhs as on 31st March 2026 recoverable from Addwaya Chemicals Private Limited. The company has not made any provision against the said amount in view of the reasons stated in the said note regarding its expected recoverability as per the assessment of the company.

Our opinion is not modified in respect of these matters.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the Standalone Financial Statements of the current period. 1 Background of the Company:

Esprit Stones Limited [Formerly known as Esprit Stones Private Limited] ('the Company') is a public limited company domiciled and incorporated in India under the Companies Act 2013 on 19 October 2016. The Company is public limited company with effect from 02 February 2024 vide the new CIN U74999RJ2016PLC056284. A fresh certificate of incorporation consequent to the conversion of private to public limited company was issued by the Registrar of Companies, Jaipur on 05 February 2024 under section 18 of the Companies Act, 2013 to give the effect of conversion.

The Company is primarily involve in artificial quartz surfaces which is a luxurious substitute of natural marble and granite. Its export customers are from USA, Canada, UAE and other countries. The Company market its product under the brand name "Haique".

The Company's registered office is at SP-1, Udyog Vihar, Sukher Industrial Area, Udaipur, Rajasthan, India, 313004 and its manufacturing units are located near Udaipur, Rajasthan. The Company got itself listed on the SME platform of National Stock Exchange (NSE-Emerge) in the financial year 2024-25.

2 Significant accounting policies

2.1 Basis of Preparation of Financial Statements

The financial statements are prepared under the historical cost convention on accrual basis to comply in all material aspects and in accordance with Indian Generally Accepted Accounting Principles (GAAP), which comprises of mandatory accounting standards as prescribed under Section 133 of the Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014, the provisions of the Act (to the extent notified). The accounting policies have been consistently applied by the Company unless otherwise stated.

2.2 Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of the financial statements and the reported amount of revenues and expenses during the reporting period. The estimates and assumptions used in the accompanying financial statements are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements. The examples of such estimates include, the useful life of tangible and intangible fixed assets, allowances for doubtful debts / advances, future obligations in respect of retirement benefit plans etc. Actual results may differ from the estimates and assumptions and in such case, the difference is recognised in the period in which the results are known.

2.3 Revenue Recognition

- (a) The company recognises revenues on the sale of products, net of discounts, when the products are dispatched /delivered to the customer/ dealer or when delivered to the carrier for export sales, which is when risks and rewards of ownership pass to the customer/ dealer.
- (b) Revenue is recognized when it is earned and no significant uncertainty exists as to its realization or collection.
- (c) Interest is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.
- (d) Dividend income is recognized when the company's right to receive dividend is established.
- (e) Export entitlements under the duty remission scheme are recognized as income on accrual basis

2.4 Recognition of Expenditure

Expenses are accounted for on an accrual basis and provision is made for all known losses and liabilities.

2.5 Tangible fixed assets

- (a) Tangible fixed assets are stated at cost less accumulated depreciation and impairment loss, if any.
- (b) The cost of Fixed Asset comprises its purchase price including non-refundable taxes & duties and directly attributable cost of bringing the asset (including leasehold improvements) to its working condition for its intended use. Subsequent upgradation / enhancements which results in an increase in the future benefits from such assets, beyond the previously assessed standard of performance, are also capitalised. Machinery spares which can be used only in connection with an item of tangible assets and whose use is not regular nature are written off over the estimated useful life of relevant assets.
- (c) All costs, including borrowing costs till commencement of commercial production, attributable to fixed assets are capitalized.
- (d) The depreciation has been charged as per below useful life:

2.6 Intangible Assets and amortization

Intangible assets are stated at cost less accumulated amortization. Intangible assets are amortized on a straight line basis over their estimated useful life of 3 years

2.7 Impairment of Assets

The carrying amounts of assets are reviewed at each Balance Sheet date if there is any indication of impairment based on internal / external factors. An asset is impaired when the carrying amount of the asset exceeds the recoverable amount. An impairment loss is charged to the Statement of Profit and Loss in the year in which an asset is identified as impaired. An impairment loss recognized in prior accounting periods is reversed if there has been change in the estimate of the recoverable amount.

2.8 Capital Work-in-Progress

Capital work-in-progress comprises cost of fixed assets that are not yet ready for their intended use at the balance sheet date.

2.9 Depreciation and amortization

(a) Owned assets

- (i) Depreciation on fixed assets is provided on straight line method, at the rates and in the manner prescribed in Schedule II to the Companies Act, 2013. In case of plant and machinery used for double or triple shift, depreciation is increased to 150% and 200% of normal depreciation respectively.
- (ii) Significant components of assets having a life shorter than the main asset, if any is depreciated over the shorter life.

(b) Leased assets:

- (i). Leasehold lands are amortised over the period of lease.
- (ii). Buildings constructed on leasehold land are depreciated based on the useful life specified in Schedule II to the Companies Act, 2013, where the lease period is beyond the life of the building.
- (iii). In other cases, buildings constructed on leasehold lands are amortized over the primary lease period of the lands.

2.10 Investments

Current investments that are readily realisable and are intended to be held for not more than one year from the date on which such investments are made, are carried at lower of cost and quoted / fair value, computed category wise. Long Term Investments are stated at cost. However, provision for diminution in the value of long term investments is made only if such a decline is other than temporary.

2.11 Inventories

Inventories are valued at the lower of cost and net realizable value. Obsolete, slow moving and defective inventories are identified at the time of physical verification and necessary provision is made for such inventories. The cost is determined using the weighted average cost method for all categories of inventories. Cost includes in case of Raw materials, Stores & spares, Packing material and consumables the purchase price and attributable direct cost less discounts. In case of Work-in-Progress and finished goods cost includes direct labour, material costs and production overheads

2.12 Foreign Currency Transactions

- (a) Transactions denominated in foreign currencies are normally recorded on the initial recognition in the reported currency using the exchange rates prevailing on the date of transaction.
- (b) Monetary assets & liabilities denominated in foreign currencies are restated at the appropriate rates of exchange prevailing on the date of Balance Sheet. The Company uses exchange rates from Foreign Exchange Dealer's Association of India (FEDAI) and the resultant gain or loss is accounted in the period in which they arise.
- (c) Any income or expense on account of exchange difference either on settlement or on translation of monetary items are recognized in the Statement of Profit and Loss for the period in which they arise.
- (d) In respect of Forward Exchange contracts entered into to hedge foreign currency risks, the difference between the forward rate and exchange rate at the inception of the contract is recognized as income or expense over the life of the contract. Further, the exchange differences arising on such contracts are recognized as income or expense along with the exchange differences on the underlying assets / liabilities. Further, in case of other contracts with committed exchange rates, the underlying is accounted at the rate so committed. Profit or loss on cancellations / renewals of forward contracts is recognized during the year. In case of option contracts, the losses are accounted on mark to market basis.

2.13 Earning Per Share

Basic earnings per share is calculated by dividing the net profit for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

2.14 Borrowing Cost

Interest and other borrowing costs attributable to qualifying assets are capitalized. A qualifying asset is an asset that necessarily requires a substantial period of time (generally over 12 months) to get ready for its intended use or sale. Other interest and borrowing costs are charged to statement of Profit & Loss.

2.15 Employee Benefits

(a) Short Term Employee Benefits:

All employee benefits payable wholly within 12 months of rendering service are classified as short term employee benefit. Benefits such as Salaries, Wages, performance incentives, expected cost of bonus, exgratia are recognised during the period in which employee renders related service.

(b) Post-employment Benefits:

Defined contribution plans: Company's contribution paid / payable during the year to employees state insurance scheme and Provident Fund are recognised during the period.

Defined benefit plans: For defined benefit schemes in the form of gratuity, the cost of providing benefits is determined using the Project Unit Credit Method, with actuarial valuations being carried out at each balance sheet date, which recognises each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation.

The obligation is measured at the present value of the estimated future cash flows. The discounting rate used for determining the present value of the obligation under defined benefit plans, is based on the market yields on government securities as at the balance sheet date, having maturity periods approximately to the terms of related obligations.

Actuarial gains/losses are recognised in full in the statement of profit and loss, for the period in which they occur. Past service cost is recognised immediately to the extent that the benefits are already vested, and otherwise is amortised on a straight-line basis over the average period until the benefits become vested. The retirement benefit obligations recognised in the balance sheet represents that present value of the defined benefit obligation as adjusted for unrecognised past service cost.

(c) Termination benefits

Termination benefits are recognised as an expense in the period in which they are incurred.

2.16 Leases

A lease is classified at the inception date as finance lease or an operating lease. A lease that transfers substantially all the risks and rewards incidental to ownership to the Company is classified as a finance lease. The Company as a lessee:

(i) **Operating lease:** Rentals payable under operating leases are charged to the statement of profit and loss on a straight line basis over the term of the relevant lease.

(ii) **Finance leases:** Finance leases are capitalised at the commencement of lease, at the lower of the fair value of the property or the present value of the minimum lease payments. The corresponding liability to the lessor is included in the balance sheet as a finance lease obligation. Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are charged directly against income over the period of the lease.

2.17 Provisions, Contingent Liabilities, Contingent Assets and commitments

(a) Provisions:

Provisions are recognised when there is a present obligation as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and there is a reliable estimate of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance sheet date and are not discounted to its present value.

(b) Contingent Liabilities:

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non occurrence of one or more uncertain future events not wholly within the control of the company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made.

(c) Contingent Assets:

Contingent Assets are neither recognised nor disclosed in the financial statements

(d) Commitments:

Commitments include the amount of purchase order (net of advances) issued to parties for completion of assets

2.18 Accounting for Taxes on Income

(a) Current tax

Current tax is measured at the amount expected to be paid to the tax authorities in accordance with the provisions of the Income-tax Act, 1961

(b) Deferred Tax

Deferred tax assets and liabilities are recognised by computing the tax effect on timing differences which arise during the year and reverse in the subsequent periods. Deferred tax assets against unabsorbed depreciation and carried forward loss under tax laws, are recognised only to the extent that there is virtual certainty supported by convincing evidence that sufficient future taxable income will be available against which such deferred tax assets can be realised. Deferred tax assets on other timing differences are recognised only to the extent that there is a reasonable certainty that sufficient future taxable income will be available against which such deferred tax assets can be realised.

- (b) Current and Deferred tax is measured based on the provisions of tax laws and tax rates enacted or substantively enacted as at the Balance Sheet date.

2.19 Government Grants

The Company has received government grants related to revenue expenses, which are deducted from related revenue expenses for the year.

2.20 Cash and Cash Equivalents

Cash comprises cash on hand and demand deposits with banks

Cash equivalents are short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to insignificant risk of changes in value

The management believes that basis of ground of appeals, and the chances of quashing the order are higher than confirmation of order by the Honorable Appellate Authority, accordingly, no liability has been provided.

a2 Effective December 2025, the Company exports certain shipments of quartz surface products to the United States of America being the Importer of Record for such exports. The quartz surface products from India in the USA are subject to antidumping duty (ADD) and countervailing duty (CVD) orders imposed by the U.S. Department of Commerce. The final liability in respect of such duties is subject to determination by the U.S. Department of Commerce through periodic administrative reviews, the outcome of which may result in additional liability or refund. Further, the Company ascertains its exposure in this regard at the close of each reporting period to identify and evaluate any contingent liabilities arising therefrom, in accordance with Accounting Standard. Based on such evaluation as at the balance sheet date, no material contingent liability has been identified / the matter has been disclosed as a contingent liability, amount unascertainable, in view of the uncertainty surrounding the outcome. Administrative review for ADD for the period 01 June 2024 to 31 May 2025 was initiated and is pending as at the balance sheet date. However, for CVD as at Balance Sheet Date no Administrative review is initiated or pending. The Company does not expect the outcome of the above matter to have a material adverse effect on its financial position.

(b) Commitments

The Company has imported plant and machinery under EPCG scheme without paying custom duty, as a consequences in the event that certain terms and conditions are not fulfilled, the company is committed to pay the consequential taxes, levies etc. The Company has issued required Bank Guarantee in favour of DGFT (Director General of Foreign Trade) against the same. The outstanding bank guarantee as on 31 March 2026 is INR 29.70 lakhs (31 March 2025 : INR 29.70 lakhs). The total export obligation against these licenses is USD 44,38,667 (31 March 2025 USD 44,38,667). The Company has completed obligations under some of the licenses and redemption is under process.

Opinion

We have audited the accompanying consolidated financial statements of **Esprit Stones Limited (Formerly known as Esprit Stones Private Limited)** ("the Company") and its subsidiaries (the Company and its subsidiaries together referred to as the "Group"), which comprise the Consolidated Balance Sheet as at March 31, 2026, the Consolidated Statement of Profit, the Consolidated Statement of Cash Flows for the year then ended and notes to the Consolidated Financial Statement, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as the "consolidated financial statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid consolidated financial statements, give the information required by the Companies Act, 2013 (the "Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the consolidated state of affairs of the Group as at March 31, 2026 and their consolidated Loss and its consolidated cash flows for the year ended.

Basis of Opinion

We conducted our audit of the consolidated financial statements in accordance with the Standards on Auditing ("SAs") specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("ICAI") together with the ethical requirements that are relevant to our audit of the consolidated financial statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion on the consolidated financial statements.

In our opinion and to the best of our information and according to the explanations given to us, these consolidated financial statement include the financial statement of the following entity:

Emphasis of Matter

We draw attention to the Note no 38, regarding the matter that during the year under audit of the standalone financial statements, the Company has disposed off its entire equity stake (51%) in Addwaya Chemicals Private Limited for a consideration of Rs. 120.87 lakhs resulting in the cessation of its status as a subsidiary with effect from 30th September 2025. These shares were acquired by Mr. Pranav Banthia and Mrs. Seema Banthia. The resultant profit/loss arising from such disposal has been duly recognized and accounted in the standalone/ consolidated financial statements of the Company for the year.

Subsequent to the disposal of its controlling interest, the Company continues to provide a corporate guarantee to the bank in respect of the said company's bank credit facilities which amounting Rs. 742 Lakhs and continues to hold an inter-corporate loan balance of Rs. 516.50 lakhs and interest amount to Rs 46.49 Lakhs as on 31st March 2026 recoverable from Addwaya Chemicals Private Limited. The company has not made any provision against the said amount in view of the reasons stated in the said note regarding its expected recoverability as per the assessment of the company.

Our opinion is not modified in respect of these matters.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements of the current period. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matters described below to be the key audit matters to be communicated in our report.

<u>The Key Audit Matter</u>	<u>How was the matter addressed in our audit</u>
<u>Revenue Recognition</u>	
Revenue is one of the key profit drivers. Cut-off is the key assertion insofar as revenue recognition is concerned, since an inappropriate cut-off can result in material misstatement of results for the year.	Our audit procedures with regard to revenue recognition included testing controls, around dispatches/ deliveries, inventory reconciliations and substantive testing for cut-offs and analytical review procedures.

Information other than the Financial Statements and Auditor's Report thereon

The Company's management and Board of Directors are responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the standalone financial statements and our auditors' report thereon. These reports are expected to be made available to us after the date of this audit report.

Our opinion on the Consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. Since these reports are expected to be made available to us after the date of this audit report hence currently, we have nothing to report in this regard.

Management's and Board of Directors' Responsibilities for the Consolidated Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation and presentation of these Consolidated Financial Statements that give a true and fair view of the consolidated financial position, consolidated financial performance and consolidated cash flows of the Group in accordance with the other accounting principles generally accepted in India. The respective Boards of Directors of the companies included in the Group are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Group and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the consolidated financial statements by the Directors of the Company, as aforesaid.

In preparing the consolidated financial statements, the respective Boards of Directors of the companies included in the Group are responsible for assessing the ability of the respective entities to continue as a going concern, disclosing, as

applicable, matters related to going concern and using the going concern basis of accounting unless the respective Boards of Directors either intend to liquidate their respective entities or to cease operations, or have no realistic alternative but to do so.

The respective Board of Directors of the companies included in the Group are also responsible for overseeing the company's financial reporting process.

Auditor's Responsibilities for the Audit of the Consolidated Financial Statements

Our objectives are to obtain reasonable assurance about whether the consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances but not for the purpose of expressing an opinion on whether the company and its subsidiaries company has adequate internal financial control with reference to financial statement in place and operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the ability of the Group to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Group to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision and performance of the audit of the financial statements of such entities included in the consolidated financial statements of which we are the independent auditors.

Materiality is the magnitude of misstatements in the consolidated financial statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the standalone financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the consolidated financial statements.

We communicate with those charged with governance of the Company and such other entities included in the consolidated financial statements of which we are the independent auditors regarding, among other matters, the

planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the consolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Report on Other Legal and Regulatory Requirements

1. With respect to the matters specified in paragraphs 3(xxi) and 4 of the Companies (Auditor's Report) Order, 2020 (the "Order"/ "CARO") issued by the Central Government in terms of Section 143(11) of the Act, to be included in the Auditor's report, according to the information and explanations given to us, and based on the CARO reports issued by us for the Company and its subsidiaries included in the consolidated financial statements of the Company, to which reporting under CARO is applicable, we report that there are no qualifications or adverse remarks in these CARO reports.

 - a) We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit of the aforesaid consolidated financial statements.
 - b) In our opinion, proper books of account as required by law relating to preparation of the aforesaid consolidated financial statements have been kept by the Company so far as it appears from our examination of those books.
 - c) The Consolidated Balance Sheet, the Consolidated Statement of Profit and Loss including Consolidated Statement of Cash Flows dealt with by this Report are in agreement with the books of accounts maintained for the purpose of preparation of the consolidated financial statements.
 - d) In our opinion, the aforesaid consolidated financial statements comply with the specified under Section 133 of the Act.
 - e) On the basis of the written representations received from the directors of the Company as on March 31, 2026 taken on record by the Boards of Directors of the Company and the reports of the statutory auditors of its subsidiaries companies incorporated in India, none of the directors of the Group companies incorporated in India is disqualified as on March 31, 2026 from being appointed as a director in terms of Section 164 (2) of the Act.
 - f) With respect to the adequacy of the internal financial controls over financial reporting and the operating effectiveness of such controls, refer to our separate Report in "Annexure I" which is based on the auditors' reports of the Company and its subsidiaries company incorporated in India. Our report expresses an unmodified opinion on the adequacy and operating effectiveness of internal financial controls over financial reporting of those companies.
 - g) With respect to the other matters to be included in the Auditor's Report in accordance with the requirements of section 197(16) of the Act, as amended:
In our opinion and to the best of our information and according to the explanations given to us, the remuneration paid by the Company to its directors during the year is in accordance with the provisions of section 197 of the Act.



- h) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, as amended in our opinion and to the best of our information and according to the explanations given to us:
- i. The Note 27 to the consolidated financial statements disclose the impact of pending litigations on the consolidated financial position of the Group.
 - ii. Provision has been made in the consolidated financial statements, as required under the applicable law or accounting standards, for material foreseeable losses, if any, on long term contracts including derivative contracts.
 - iii. There has been no delay in transferring amounts, required to be transferred, to the Investor Education and Protection Fund by the Company.
 - iv. a) The management has represented that, to the best of its knowledge and belief, as disclosed in Note 35(k) of the Consolidated Financial Statements, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the company to or in any other person(s) or entity(ies), including foreign entities ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, whether, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the company ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.
 - b) The management has represented, that, to the best of its knowledge and belief, as disclosed in Note 35(k) of the Consolidated Financial Statements, no funds have been received by the company from any person(s) or entity(ies), including foreign entities ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the company shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries;
 - c) Based on the audit procedures that have been considered reasonable and appropriate in the circumstances, nothing has come to our notice that has caused us to believe that the representations under sub-clause (i) and (ii) of Rule 11 (e) as provided under (A) and (B) above contain any material misstatement.
 - v. Based on our examination which included test checks, the company and subsidiaries have used an accounting software for maintaining its books of account which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit we did not come across any instance of audit trail feature being tampered with and audit trail has been preserved by the company as per statutory requirements.

Notes to consolidated financial statements

1 Background of the Company:

Esprit Stones Limited [Formerly known as Esprit Stones Private Limited] ('the Company') is a public limited company domiciled and incorporated in India under the Companies Act 2013 on 19 October 2016. The Company is public limited company with effect from 02 February 2024 vide the new CIN U74999RJ2016PLC056284. A fresh certificate of incorporation consequent to the conversion of private to public limited company was issued by the Registrar of Companies, Jaipur on 05 February 2024 under section 18 of the Companies Act, 2013 to give the effect of Esprit Stones Limited and its subsidiaries ('the Group' or 'the Esprit group') is primarily involved in engineered stones such as engineered quartz surfaces and engineered marble surfaces which is a luxurious substitute of natural marble and granite. Its export customers are in the USA, Canada and other countries. The Company market its engineered stones product in India under its brand "Haique". The Company's registered office is at SP-1, Udyog Vihar, Sukher Industrial Area, Udaipur, Rajasthan, India, 313004 and its manufacturing units are located at Udaipur, Salumber and Rajasamand in the state of Rajasthan.

The Company got itself listed on the SME platform of National Stock Exchange (NSE-Emerge) in the financial year 2024-25.

2 Material accounting policies

2.1 Preparation of Consolidated Financial Statements

I) Basis of Preparation of Consolidated Financial Statements

These consolidated financial statements are prepared under the historical cost convention on accrual basis to comply in all material aspects and in accordance with Indian Generally Accepted Accounting Principles (GAAP), which comprises of mandatory accounting standards as prescribed under Section 133 of the Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014, the provisions of the Act (to the extent notified). The accounting policies have been consistently applied by the Company unless otherwise stated.

II) Principles and details of consolidation

The consolidated financial statements relate to Esprit Stones Private Limited ('the Company') and its subsidiary companies namely:

- (i) Haique Stones Private Limited (100% Wholly Owned Subsidiary)
- (ii) Addwaya Chemicals Private Limited (51% is held by the Company) upto 30 September 2025
- (iii) Haique Stones Inc. (100% Wholly Owned Subsidiary)

The consolidated financial statements have been prepared on the following basis:

- a) The financial statements of the Company and its subsidiary companies are combined on a line-by-line basis by adding together the book values of like items of assets, liabilities, income and expenses, after fully eliminating intra-group balances and intra-group transactions in accordance with Accounting Standard (AS) 21 - "Consolidated Financial Statements".
- b) The difference between the cost of investment in the subsidiary, over the net assets at the time of acquisition of shares in the subsidiary is recognised in the financial statements as Goodwill or Capital Reserve, as the case may be.
- c) The difference between the proceeds from disposal of investment in subsidiary and the carrying amount of its assets less liabilities as of the date of disposal is recognised in the consolidated Profit and Loss Statement being the profit or loss on disposal of investment in subsidiary.
- d) Minority Interest's share of net assets of consolidated subsidiary is identified and presented in the consolidated balance sheet separate from liabilities and the equity of the Company's shareholders.
- e) The Company accounts for its share of post-acquisition changes in net assets of associates, after eliminating unrealised profits and losses resulting from transactions between the Company and its associates to the extent of its share, through its Consolidated Profit and Loss Statement, to the extent such change is attributable to the associates' Profit and Loss Statement and through its reserves for the balance based on available information.
- f) As far as possible, the consolidated financial statements are prepared using uniform accounting policies for like transactions and other events in similar circumstances and are presented in the same manner as the Company's separate financial statements.
- g) The books of accounts of foreign subsidiaries are in US Dollars however for preparation of the financials in Indian Rupees (INR), Accounting Standard (AS) 11 - "The Effects of Changes in Foreign Exchange Rates" as issued by Institute of Chartered Accounts of India has been followed. Accordingly, translation is done as a) The items of income and expenditure are translated at Average exchange rate of INR 94.8350 per USD except Intra-group transactions. b) The assets and liabilities are translated at closing exchange rates. c) Intra-group transactions and balances are translated at the conversion rates being used by Foreign Companies to facilitate elimination for preparation of consolidated financial statements. The resulting exchange difference is accumulated in the Foreign Currency Translation Reserve and is shown under Reserves and Surplus.
- h) there were no material amounts which have been adjusted for, in arriving at profit / loss of the respective periods; and

III) Other material accounting policies

These are set out under "Material accounting Policies" as given in the Company's separate financial statements.

2.2 Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of the financial statements and the reported amount of revenues and expenses during the reporting period. The estimates and assumptions used in the accompanying financial statements are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements. The examples of such estimates include, the useful life of tangible and intangible fixed assets, allowances for doubtful debts / advances, future obligations in respect of retirement benefit plans etc. Actual results may differ from the estimates and assumptions and in such case, the difference is recognised in the period in which the results are known.

2.3 Revenue Recognition

- (a) The Group recognises revenues on the sale of products, net of discounts, when the products are dispatched / delivered to the customer/ dealer or when delivered to the carrier for export sales, which is when risks and rewards of ownership pass to the customer/ dealer.
- (b) Revenue is recognized when it is earned and no significant uncertainty exists as to its realization or collection.
- (c) Interest is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.
- (d) Dividend income is recognized when the company's right to receive dividend is established.
- (e) Export entitlements under the duty remission scheme are recognized as income on accrual basis

2.4 Recognition of Expenditure

Expenses are accounted for on an accrual basis and provision is made for all known losses and liabilities.

2.5 Property plant and equipments

- (a) Tangible fixed assets are stated at cost less accumulated depreciation and impairment loss, if any.
- (b) The cost of Fixed Asset comprises its purchase price including non-refundable taxes & duties and directly attributable cost of bringing the asset (including leasehold improvements) to its working condition for its intended use. Subsequent upgradation / enhancements which results in an increase in the future benefits from such assets, beyond the previously assessed standard of performance, are also capitalised. Machinery spares which can be used only in connection with an item of tangible assets and whose use is not regular nature are written off over the estimated useful life of relevant assets.
- (c) All costs, including borrowing costs till commencement of commercial production, attributable to fixed assets are capitalized.
- (d) The depreciation has been charged as per below useful life:

2.6 Intangible Assets and amortization

Intangible assets are stated at cost less accumulated amortization. Intangible assets are amortized on a straight line basis over their estimated useful life of 3 years

2.7 Impairment of Assets

The carrying amounts of assets are reviewed at each Balance Sheet date if there is any indication of impairment based on internal / external factors. An asset is impaired when the carrying amount of the asset exceeds the recoverable amount. An impairment loss is charged to the Statement of Profit and Loss in the year in which an asset is identified as impaired. An impairment loss recognized in prior accounting periods is reversed if there has been change in the estimate of the recoverable amount.

2.8 Capital Work-in-Progress

Capital work-in-progress comprises cost of fixed assets that are not yet ready for their intended use at the balance sheet date.

2.9 Depreciation and amortization

(a) Owned assets

- (i) Depreciation on fixed assets is provided on straight line method, at the rates and in the manner prescribed in Schedule II to the Companies Act, 2013. In case of plant and machinery used for double or triple shift, depreciation is increased to 150% and 200% of normal depreciation respectively.
- (ii) Significant components of assets having a life shorter than the main asset, if any is depreciated over the shorter life.

(b) Leased assets:

- (i). Leasehold lands are amortised over the period of lease.
- (ii). Buildings constructed on leasehold land are depreciated based on the useful life specified in Schedule II to the Companies Act, 2013, where the lease period is beyond the life of the building.
- (iii). In other cases, buildings constructed on leasehold lands are amortized over the primary lease period of the lands.

2.10 Investments

Current investments that are readily realisable and are intended to be held for not more than one year from the date on which such investments are made, are carried at lower of cost and quoted / fair value, computed category wise. Long Term Investments are stated at cost. However, provision for diminution in the value of long term investments is made only if such a decline is other than temporary.

2.11 Inventories

Inventories are valued at the lower of cost and net realizable value. Obsolete, slow moving and defective inventories are identified at the time of physical verification and necessary provision is made for such inventories. The cost is determined using the weighted average cost method for all categories of inventories. Cost includes in case of Raw materials, Stores & spares, Packing material and consumables the purchase price and attributable direct cost less discounts. In case of Work-in-Progress and finished goods cost includes direct labour, material costs and production overheads

2.12 Foreign Currency Transactions

- (a) Transactions denominated in foreign currencies are normally recorded on the initial recognition in the reported currency using the exchange rates prevailing on the date of transaction.
- (b) Monetary assets & liabilities denominated in foreign currencies are restated at the appropriate rates of exchange prevailing on the date of Balance Sheet. Resultant gain or loss is accounted in the period in which they arise
- (c) Any income or expense on account of exchange difference either on settlement or on translation of monetary items are recognized in the Statement of Profit and Loss for the period in which they arise
- (d) In respect of Forward Exchange contracts entered into to hedge foreign currency risks, the difference between the forward rate and exchange rate at the inception of the contract is recognized as income or expense over the life of the contract. Further, the exchange differences arising on such contracts are recognized as income or expense along with the exchange differences on the underlying assets / liabilities. Further, in case of other contracts with committed exchange rates, the underlying is accounted at the rate so committed. Profit or loss on cancellations / renewals of forward contracts is recognized during the year. In case of option contracts, the losses are accounted on mark to market basis.

2.13 Earning Per Share

Basic earnings per share is calculated by dividing the net profit for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

2.14 Borrowing Cost

Interest and other borrowing costs attributable to qualifying assets are capitalized. A qualifying asset is an asset that necessarily requires a substantial period of time (generally over 12 months) to get ready for its intended use or sale. Other interest and borrowing costs are charged to statement of Profit & Loss.

2.15 Employee Benefits

(a) Short Term Employee Benefits:

All employee benefits payable wholly within 12 months of rendering service are classified as short term employee benefit. Benefits such as Salaries, Wages, performance incentives, expected cost of bonus, exgratia are recognised during the period in which employee renders related service.

(b) Post-employment Benefits:

Defined contribution plans: Group's contribution paid / payable during the year to employees state insurance scheme, Provident Fund and Labour welfare fund are recognised during the period.

Defined benefit plans: For defined benefit schemes in the form of gratuity, the cost of providing benefits is determined using the Project Unit Credit Method, with actuarial valuations being carried out at each balance sheet date, which recognises each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation.

The obligation is measured at the present value of the estimated future cash flows. The discounting rate used for determining the present value of the obligation under defined benefit plans, is based on the market yields on government securities as at the balance sheet date, having maturity periods approximately to the terms of related obligations.

Actuarial gains/losses are recognised in full in the statement of profit and loss, for the period in which they occur. Past service cost is recognised immediately to the extent that the benefits are already vested, and otherwise is amortised on a straight-line basis over the average period until the benefits become vested. The retirement benefit obligations recognised in the balance sheet represents that present value of the defined benefit obligation as adjusted for unrecognised past service cost

(c) Termination benefits

Termination benefits are recognised as an expense in the period in which they are incurred.

2.16 Leases

A lease is classified at the inception date as finance lease or an operating lease. A lease that transfers substantially all the risks and rewards incidental to ownership to the Group is classified as a finance lease. The Group as a lessee:

- (i) **Operating lease:** Rentals payable under operating leases are charged to the statement of profit and loss on a straight line basis over the term of the relevant lease.
- (ii) **Finance leases:** Finance leases are capitalised at the commencement of lease, at the lower of the fair value of the property or the present value of the minimum lease payments. The corresponding liability to the lessor is included in the balance sheet as a finance lease obligation. Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are charged directly against income over the period of the lease.

2.17 Provisions, Contingent Liabilities, Contingent Assets and commitments

(a) Provisions:

Provisions are recognised when there is a present obligation as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and there is a reliable estimate of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance sheet date and are not discounted to its present value.

(b) Contingent Liabilities:

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non occurrence of one or more uncertain future events not wholly within the control of the Group or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made.

(c) Contingent Assets:

Contingent Assets are neither recognised nor disclosed in the financial statements

(d) Commitments:

Commitments include the amount of purchase order (net of advances) issued to parties for completion of assets

2.18 Accounting for Taxes on Income

(a) Current tax

Current tax is measured at the amount expected to be paid to the tax authorities in accordance with the provisions of the Income-tax Act, 1961 and Delaware and US Federal for foreign subsidiaries.

(b) Deferred Tax

Deferred tax assets and liabilities are recognised by computing the tax effect on timing differences which arise during the year and reverse in the subsequent periods. Deferred tax assets against unabsorbed depreciation and carried forward loss under tax laws, are recognised only to the extent that there is virtual certainty supported by convincing evidence that sufficient future taxable income will be available against which such deferred tax assets can be realised. Deferred tax assets on other timing differences are recognised only to the extent that there is a reasonable certainty that sufficient future taxable income will be available against which such deferred tax assets can be realised.

(c) Current and Deferred tax is measured based on the provisions of tax laws and tax rates enacted or substantively enacted as at the Balance Sheet date.

2.19 Segment reporting

Each of the reportable segments derives its revenues from the main products and hence these have been identified as reportable segments by the management of the group. Segment revenue, result, assets and liabilities include the respective amounts identifiable to each of the segments and amount allocated on a reasonable basis. Unallocated expenditure consists of common expenditure incurred for all the segments and expenses incurred at corporate level. The assets and liabilities that cannot be allocated between the segments are shown as unallocated corporate assets and unallocated corporate liabilities respectively.

2.20 Government Grants

The Group has received government grants related to revenue expenses, which are deducted from related revenue expenses for the year.

2.21 Cash and Cash Equivalents

Cash comprises cash on hand and demand deposits with banks

Cash equivalents are short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to insignificant risk of changes in value

a2 Custom duties on import of quartz surfaces in the USA from India

The Company's subsidiary imports Quartz Surfaces in the United States of America (USA) from India and effective December 2025, the Company also exports certain shipments of quartz surface products to the United States of America being the Importer of Record for such exports. The quartz surface products from India in the USA are subject to antidumping duty (ADD) and countervailing duty (CVD) orders imposed by the U.S. Department of Commerce. The final liability in respect of such duties is subject to determination by the U.S. Department of Commerce through periodic administrative reviews, the outcome of which may result in additional liability or refund. Further, the Company ascertains its exposure in this regard at the close of each reporting period to identify and evaluate any contingent liabilities arising therefrom, in accordance with Accounting Standard. Based on such evaluation as at the balance sheet date, no material contingent liability has been identified / the matter has been disclosed as a contingent liability, amount unascertainable, in view of the uncertainty surrounding the outcome. Administrative review for ADD for the period 01 June 2024 to 31 May 2025 was initiated and is pending as at the balance sheet date. However, for CVD as at Balance Sheet Date no Administrative review is initiated or pending. The Company does not expect the outcome of the above matter to have a material adverse effect on its financial position.

(b) Commitments

The Group has imported plant and machinery under EPCG scheme without paying custom duty, as a consequences in the event that certain terms and conditions are not fulfilled, the company is committed to pay the consequential taxes, levies etc. The Group has issued required Bank Guarantee in favour of DGFT (Director General of Foreign Trade) against the same. The outstanding bank guarantee as on 31 March 2026 is INR 31.80 lakhs (31 March 2025 : INR 31.80 lakhs). The total export obligation against these licenses is USD 5,067,072 (31 March 2025 : USD 5,067,072). The Group has completed obligations under some of the licenses and redemption is under process.

C Impact of New Labour Codes

(a) During the month of March 2025, one of subsidiary M/s Addwaya Chemicals Private Limited ('the erstwhile subsidiary') in which the Company was holding 51% shareholding has received direction for closure of the industry from the Regional Office of Rajasthan State Pollution Control Board, ('RSPCB'), District-Rajsamand, State-Rajasthan under Section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and Section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981, situated at Arajai No. 1953/11, 2080/10 & 2082/11, Village-Rathujana Negdiya, Tehsil-Nathdwara, District Rajsamand, State-Rajasthan. Currently, the management of the erstwhile subsidiary is exploring possibilities for obtaining required statutory permission for re-commencing its manufacturing operations.

(b) On September 30, 2025 the company has disposed its entire holding of 51% in the said company for INR 120.87 lakhs based on its current valuation duly certified by the registered valuer, The Company has sold the said investment at current fair value, the results of the subsidiary up to date of disposal i.e. 30 September 2025 are included in consolidated financial results of the entity. Accordingly, the net gain on disposal of subsidiary of INR 52.49 lakhs has been disclosed as an exceptional in statement of profit and loss for the six months ended September 30, 2025.

(c) The Company had given Corporate Guarantee (CG) on behalf of Addwaya Chemicals Private Limited while it was subsidiary of the Company against the credit facilities availed from HDFC Bank Limited. The said CG is maintained as per the terms with HDFC Bank Limited. The outstanding exposure of credit facilities against which CG was given was INR 1,756 lakhs as on September 30, 2025, which is reduced to INR 604 lakhs as on date.

(d) The Company had given loan of INR 516.50 lakhs to Addwaya Chemicals Private Limited while it was subsidiary of the Company, which is outstanding as on date, Based on its estimates and commitment, the management of the erstwhile subsidiary is confident of repaying this loan hence no adjustment to the books have been made in this regard.
