BRIEF PROCEEDINGS OF 08TH ANNUAL GENERAL MEETING OF HARDWYN INDIA LIMITED HELD ON WEDNESDAY, 12TH NOVEMBER, 2025 AT 12:30 P.M. THROUGH VIDEO CONFERENCING ("VC") / OTHER AUDIO-VISUAL MEANS ("OAVM")

Ms. Ankita Jain, Company Secretary & Compliance Officer welcomed all Members, Directors and other invitees to the 08th Annual General Meeting (AGM) of the members of Hardwyn India Limited ('the Company') held on Wednesday, 12th November, 2025 at 12:30 P.M. IST through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM").

All the Directors of the Company except Mr. Kulmeet Singh Lamba, attended the meeting. It was informed that the meeting was held through Video Conferencing VC/ OAVM without the physical presence of the members at a common venue in accordance with the various Circulars issued by Ministry of Corporate Affairs.

Since there was no physical attendance of Members and in compliance with the Circulars issued by the MCA and SEBI, the requirement of appointing proxies was not applicable, except for the authorized representatives of corporate shareholders.

With permission of the Chairman, the Notice convening the Meeting, having been circulated to all the Members, was taken as read.

Ms. Ankita Jain, Company Secretary & Compliance Officer informed that Statutory Registers, Annual Report and other documents were made available for inspection by the Members.

The Company Secretary & Compliance Officer introduced the Directors present at the meeting to the shareholders of the company.

Mr. Rubaljeet Singh Sayal, Managing Director of the company confirmed that the quorum was present and declared the meeting in order.

The Company Secretary informed that the Members who were present at the AGM but had not cast their votes earlier through remote e-voting, may cast their vote during the AGM and explained the process of e-voting on the resolutions during the meeting through the CDSL E-voting website. He further informed that Mr. Amit Saxena & Associates, proprietor of M/s. Amit Saxena & Associates, Practicing Company Secretaries was appointed as the Scrutinizer by the Board to scrutinize the remote e-voting process prior to and during the AGM in a fair and transparent manner.

The following businesses were transacted at the meeting:

Ordinary Business:

1. To received, considered and adopted the Standalone and Consolidated Audited Financial Statements of the Company for the Financial Year ended March 31st, 2025 and reports of the Board of Directors and Auditors thereon.
2. Appointment of Ms. Tanya Sayal (DIN- 02821564), who was liable to Retire by Rotation being eligible offers herself for reappointment.
3. Re-Appointment Of M/s S.S. Periwal & Company, Chartered Accountants (FRN:001021N) As Statutory Auditors of the Company.

Special Business:

4. Re-appointment of Mr. Rubaljeet Singh Sayal (DIN: 00280624) as the Managing Director of The Company.
5. Appointment of M/s Amit Saxena & Associates, Company Secretaries as the Secretarial Auditor of the Company for a term of 5 (Five) consecutive years.
6. Increase in Authorized Share Capital of the Company from 50,00,00,000 (Rupees Fifty Crore) to 55,00,00,000 (Rupees Fifty-Five Crore) and consequential alteration of Memorandum of Association.
7. Preferential Issuance of Fully Paid-up Equity Shares to the shareholders of Fiba Hardwyn Locks Limited (“FHLL”).

Thereafter, the Company Secretary invited the speaker shareholders to ask their queries. However, due to some technical issues the shareholders were not able to ask their queries and the Company Secretary requested the members to ask their queries, if any via email.

After that, the Company Secretary requested the Members, who have not voted earlier, to cast their vote on the matters contained in the AGM Notice. The e-voting facility remained active at the CDSL e-voting platform for next 15 minutes for the Members to cast their vote. She also mentioned that the results of voting shall be announced within 2 working days of conclusion of meeting. The results of voting will be displayed on the website of the Company, CDSL and Stock Exchanges in due course.

The Company Secretary thanked the Members for their continuous support and for attending and participating at the Meeting.

The meeting concluded at 01:10 P.M. (IST) (including the time allowed for e-voting). The details of the voting results on all the resolutions as set out in the Notice of AGM along with the Scrutinizers Report shall be submitted separately in due course.
