Dear Sir,

In terms of Regulation 30 and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR) read with corresponding circulars and notifications issued thereunder, the Company viz. Havells India Limited hereby informs about an Order dated 13<sup>th</sup> March, 2025, issued by the Additional Commissioner of Customs, ICD – Patparganj, Delhi.

The requisite details in terms of Regulation 30 and sub-para 20 of Para A of Part A of Schedule III of the SEBI LODR are furnished hereunder:

- (i) Name of the Authority – Additional Commissioner of Customs, ICD – Patparganj, Delhi
- (ii) Nature and details of the action(s) taken, initiated or order(s) passed – The Company has received an Order dated 13.03.2025 issued by the Additional Commissioner of Customs, ICD Patparganj for the period April, 2019 to October, 2023, which has been received by the Company on 2<sup>nd</sup> April, 2025. As per the Order, Customs duty amounting to Rs.47,62,699/- has been ordered to recover under section 28(4) along with applicable Interest under section 28AA of the Customs Act, 1962 and Equivalent amount of Penalty as applicable under section 114A of the Customs Act, 1962.
- (iii) Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority – 2<sup>nd</sup> April, 2025
- (iv) Details of the violation(s)/contravention(s) committed or alleged to be committed – The alleged violation is in respect of the HSN classification of certain components/ raw material of Lighting products, imported by the Company. Based on the merits of the matter and prevailing laws, the Company is planning to file an Appeal against this Order with the appropriate authorities.
- (v) Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible – There is no material impact on financials, operations, or other activities of the Company.
