
This is further to our disclosure dated 18.03.2024 and 13.05.2024. Intimation is hereby given under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, that HCL Infotech Limited, a wholly owned subsidiary of the Company, has received an interim order from the High Court of Himachal Pradesh in an Appeal filed by HPSEBL against one of the awards dated 15.03.2024. Accordingly, HCL Infotech Limited has been allowed vide Order dated 31.12.2025 (received by the Company on 01.01.2026) to withdraw the amount (INR 26.93 Crore) deposited by HPSEBL alongwith complete interest, against a security (i.e., submission of a Bank Guarantee for an equivalent amount) and an Undertaking to the satisfaction of the Court. The parties have the right to file an appeal against the above order.

Pursuant to Para B of Part A of Schedule III of Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular SEBVHO/CFD/CFD-PeD-1/P/CIR/2023/123 dated July 13, 2023, and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated February 25, 2025.
