Subject: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Institution of Civil Defamation Suit and its update

Dear Sir / Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”) in accordance with Securities and Exchange Board of India Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we hereby inform you that the Company has instituted a civil defamation suit before the Hon’ble High Court of Delhi on February 19, 2026 against Sakshi Media House (including *Sakshi Telugu Newspaper* and news channel *Sakshi TV*) and other concerned parties, in connection with a series of false, baseless, malicious, and defamatory publications and social media allegations targeting the Company.

The aforesaid publications are wholly unfounded and have been made with the apparent intent to tarnish the reputation, goodwill, and credibility of the Company. In order to safeguard its interests and protect its stakeholders, the Company has initiated appropriate legal proceedings.

The Company has, inter alia, sought the following interim prayers before the Hon’ble High Court Delhi.

- 1. Permanent and Mandatory Injunction** restraining the Defendants from posting, publishing, uploading, writing, speaking, distributing, broadcasting, or republishing any false, misleading, and defamatory content concerning the Company in any manner whatsoever, including on platforms owned, controlled, or maintained by Defendant Nos. 1 to 4, as detailed in Annexure – A.
- 2. Permanent and Mandatory Injunction** directing the Defendants, their agents, representatives, affiliates, or any person acting on their behalf or under their authority, to forthwith remove and cease dissemination of all false, misleading, and defamatory content published against the Company on all platforms, including those maintained by Defendant Nos. 5 to 8. as detailed in Annexure – A.

3. **Damages of Rs.100 Crores (Rupees One Hundred Crores)** against Defendant Nos. 1 to 4 as specified in Annexure – A, on account of the grave and irreparable harm caused to the Company’s reputation and business by their defamatory acts.

The details as required under SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, in respect of the institution of the aforesaid legal proceedings are enclosed as **Annexure – A**.

Further, we wish to inform you that the company has filed a suit vide CS(OS) No.162/2026, before the Hon’ble Delhi High Court against the defendants therein inter alia seeking mandatory injunction i.e., restraining the Defendants from posting, publishing, uploading, writing, speaking, distributing, broadcasting, or republishing any false, misleading, and defamatory content concerning the Company in any manner whatsoever, including on platforms owned, controlled, or maintained by Defendant Nos. 1 to 4 and to forthwith remove and cease dissemination of all false, misleading, and defamatory content published against the Company on all platforms, including those maintained by Defendant Nos. 5 to 8 and to award the damages of Rs.100 Crores against Defendant 1 to 4. Upon submissions made by the counsel of the company,

The Hon’ble Court, vide its Order dated 19.02.2026, has been pleased to grant, inter alia, the following directions:

- a) The defendant nos. 1 to 4 and defendant no. 9 are restrained from posting, publishing, uploading, writing, speaking, distributing and/or republishing any false, misleading and defamatory content against the plaintiffs, on any web platform or in a physical newspaper, including, the platforms maintained by defendant nos. 6 to 8;
- b) The defendant nos. 1 to 4 are directed to take down the impugned article and impugned reports, and any other publication containing identical as well as similar statements, maintained on their profiles on the platforms of defendant nos. 6 to 8
- c) The defendant nos. 1 to 3 are directed to take-down within 24 hours the impugned article dated 14th February, 2026, or any other related articles published by defendant nos. 1 to 3, on their platform www.sakshi.com
- d) Defendant nos. 1 to 3 are directed to take-down, within 24 hours of this order, the impugned reports dated 14th February, 2026, or any other defamatory interview/ debate/ report published under the name of “Sakshi TV”, on various online platforms maintained by defendant nos. 6 to 8, the links of which, are given in Annexure 1 of this order;
- e) In case, the aforesaid direction is not complied with by defendant nos. 1 to 3 within 24 hours of this present order, the defendant nos. 6 to 8 shall take down the impugned content, details of which, are given in Annexure 1 of this order;

and such other directions as mentioned in the order passed by the Hon’ble High Court of Delhi.

The Company has therefore sought, inter alia, permanent and mandatory injunctions restraining further publication or circulation of such defamatory material, removal of all existing defamatory content across platforms, damages, and such other reliefs as the Hon'ble Court may deem fit and proper in the interests of justice.</p>
b)	Expected financial implications, if any due to compensation, penalty etc.	At this stage, there is no adverse financial implication on the Company arising out of the said proceedings. The Company is the plaintiff in the matter and has asserted its legal rights by claiming damages against the Defendants. I.A. 4829/2026 (For Exemption)

1. Exemption allowed, subject to all just exceptions.
2. Application is accordingly disposed of.

I.A. 4828/2026 (For enlargement of time for filing Court Fees)

3. The present application has been filed under Sections 148 and 149 read with Section 151 of the Code of Civil Procedure, 1908 ("CPC") seeking enlargement of time for affixing the already paid Court Fees.



4. This Court is informed that the plaintiffs have already paid the Court Fees of Rs. 97,65,000/- on 18th February, 2026, however, the said Court Fees is yet to be collected by them.

5. Accordingly, liberty is granted to the plaintiffs to file/affix the requisite Court Fees, within a period of one week, from today.

6. The present application is accordingly disposed of.

I.A. 4827/2026 (For Additional Reliefs under Order II Rule 2, CPC)

7. Issue notice. Notice is accepted by learned counsel appearing for defendant no. 6.

8. Issue notice to other defendants by all modes.

9. Let reply be filed within a period of four weeks.

10. Rejoinder thereto, if any, be filed within a period of two weeks, thereafter.

CS(OS) 162/2026

11. Let the plaint be registered as suit.

12. Issue summons. Summons is accepted by learned counsel appearing for defendant no. 6. The said defendant shall file its written statement within thirty (30) days, from today.

13. Issue summons to defendant nos. 1 to 5 and 7 to 9, by all permissible modes, upon filing of Process Fee.

14. Summons shall state that the written statement be filed by the said defendants within thirty (30) days from the date of receipt of summons.

15. Along with the written statement, the defendants shall also file an affidavit of admission/denial of the plaintiffs' documents, without which, the written statement shall not be taken on record.

16. Liberty is given to the plaintiffs to file replication(s), if any, within



thirty (30) days from the receipt of the written statement(s). Along with the replication(s) filed by the plaintiffs, the affidavit(s) of admission/denial of the documents of defendants be filed by the plaintiffs, without which, the replication(s) shall not be taken on record.

17. It is made clear that any unjustified denial of documents may lead to an order of costs against the concerned party.

18. If any of the parties wish to seek inspection of the documents, the same shall be sought and given within the timelines.

19. List before the Joint Registrar (Judicial) on 06th April, 2026 for completion of service.

20. List before the Court on 09th July, 2026.

I.A. 4826/2026 (under Order XXXIX Rules 1 and 2 CPC)

21. The present application has been filed seeking *ex-parte* interim reliefs against the defendants, thereby, restraining them from making, publishing, and circulating false, misleading and defamatory content against the plaintiffs.

22. It is submitted by learned Senior Counsel appearing for the plaintiffs that plaintiff no. 1—company is one of India’s leading dairy companies, and has established a reputed name for itself. The company was incorporated in the year 1992 by Mr. N. Chandrababu Naidu, who subsequently resigned in the year 1994.

23. The plaintiff no. 1 has received numerous awards and accolades for its business ethics and contributions to the society. In this regard, attention of this Court has been drawn to the following paragraphs from the plaint, which are reproduced as under:

“xxx xxx xxx



21. Plaintiff No. 1 Company was incorporated in 1992 and is engaged in the business of procurement, processing and marketing of milk and milk related products across the Nation, including Delhi. Plaintiff No. 1 since inception has maintained the highest standards of quality, ensured food and health safety. Accordingly, Plaintiff No. 1 enjoys a stellar reputation in the dairy industry.

xxx xxx xxx

23. Plaintiff No. 1 Company operates 18 state-of-the-art manufacturing units nationwide. It has a vast network across 16 States including Andhra Pradesh, Delhi NCR, Telangana, Maharashtra, Karnataka, Tamil Nadu, Rajasthan, Punjab, Haryana and Uttar Pradesh. Plaintiff No. 1 caters to millions of consumers, providing them with the best quality milk and milk related products.

xxx xxx xxx

29. The quality systems of Plaintiff No. 1 Company are benchmarked against globally recognized standards, including ISO 22000:2018, ISO 9001:2015, ISO 45001:2018, ISO 14001:2015, ISO 50001:2018, FSSC 22000 v6.0, SEDEX (Ethical), and HALAL certifications, along with full compliance with FSSAI, AgMark, BIS, and EIA requirements.

30. Plaintiff No. 1 Company has received numerous awards and accolades for its business ethics and contributions to the society. Few of the recent and significant awards given to the Plaintiff No. 1 Company are set out below:

- a. The Southern Dairy Food Conclave awarded Plaintiff No. 1 Company with the Outstanding Dairy Professional Award 2025;
- b. Golden Peacock Award for excellence in Corporate Governance 2025 at the London Global Convention;
- c. Prestigious National Energy Conservation Awards (NECA - 2023) in Dairy Sector for the year 2023 at all India level for the effective energy conservation process/methods;
- d. Certificate of Appreciation from Government of Telangana for groundwater management at Shamirpet Plant;
- e. Best South Brand Award at the Pride of India Brand Awards 2022;
- f. Bronze Medal awarded to the Bayyavaram Plant maintained by Plaintiff No. 1 Company in the Food Safety and Quality Competition Seminar, 2024;
- g. The Gokul, Main Dairy Plant of the Plaintiff No. 1 Company was awarded with National Energy Conservation Award;



h. The Telangana Government awarded the Plaintiff No. 1 Company with the Best Management Award;

i. Blinkit Brand Awards has facilitated Plaintiff No. 1 Company with the award of being the most loved brand;

j. B. Kothakota Plant of the Plaintiff No. 1 Company was awarded CII National Award in Food Safety;

k. Plaintiff No. 1 Company has been facilitated with the award for being Telangana's Best Employer Brand;

l. Best Corporate-Cash Management Services awarded by HDFC Bank; and

m. Won Platinum Award in the Digital Transformation for Heritage Vet+ Project organized by SKOCH.

xxx xxx xxx”

24. It is submitted that defendant nos. 1 to 4, on 14th February, 2026, have published false and incorrect statements in the Delhi edition of the newspaper being ‘Sakshi Newspaper’, and on the news channel being ‘Sakshi TV’, against the plaintiffs. The details of the defamatory statements published by defendant nos. 1 to 4, as given in the plaint, are as under:

“xxx xxx xxx

*31. On 14 February 2026, Defendant No. 1 in the Delhi Edition of the Newspaper published a self-authored article which contains incorrect, unfounded and defamatory statements against the Plaintiff (the “**Impugned Article**”). The Impugned Article was published on the front page of the Delhi Edition of the Newspaper with a logo of the Plaintiff No. 1 Company. The Impugned Article was published on the website of Defendant No. 1 as well as physical news paper.*

*32. The Impugned Article alleges that Plaintiff No. 1 Company has ties with Bhole Baba Oroganic Dairy Milk Private Limited (“**Bhole Baba Oroganic Milk**”). Bhole Baba Oroganic Milk is arrayed as the primary accused in the Tirumala Tirupati Devasthanams Scam involving supply of adulterated ghee (the “**TTD Scam**”).*

*33. The Impugned Article further alleges that Tirumala Tirupati Devasthanams (“**TTD**”) awarded contract in favor of Bhole Baba Oroganic Milk solely because it has business relations with Plaintiff No. 1 Company which was founded by Mr. Nara Chandrababu Naidu and is currently managed by his family members. The Impugned Article seeks to allege that Plaintiff No. 1 Company was also indulged*



in the TTD Scam as it has ties with Bhole Baba Oroganic Milk.
Relevant portion of the Impugned Article is set out below:

“Heritage Connection with “Bhole” too”

“TTD Ghee contracts to Bole Baba only during Chandrababu’s Government Tenure”

“The real conspiracy behind Chief Minister Chandrababu’s alleged smear campaign regarding the Tirumala Laddu Prasadam is gradually coming to light. It has been revealed that Chandrababu’s family shares a business relationship with Bhole Baba Dairy, the firm that the TDP coalition government has placed at the centre of this controversy.”

“Furthermore, it is noteworthy that the supply of the allegedly adulterated ghee which Chandrababu is now creating uproar about- actually occurred during the current TDP coalition government's regime. Here is the breakdown of the business nexus between Bhole Baba Dairy and Heritage Foods...”

“Heritage Foods - Bhole Baba Connection: The business relationship between N. Chandrababu Naidu’s family and Bhole Baba Dairy, which is at the center of the controversy regarding ghee supplies for the Tirumala Laddu Prasadam, has come to light. It has recently been revealed that Heritage Foods, owned by Chandrababu’s family, maintains business ties with Bhole Baba Dairy. Notably, Bhole Baba Dairy has explicitly mentioned on its official website that they have a business association with Heritage Foods. The website clearly states, “We are associated with Heritage Foods.” This indicates that a long-standing business relationship has been ongoing between the two dairies.”

xxx xxx xxx”

25. By referring to the aforesaid, learned Senior Counsel appearing for the plaintiffs submits that the impugned article alleges that the plaintiff no. 1 company has ties with Bhole Baba Oroganic Dairy Milk Private Limited (“Bhole Baba Oroganic Milk”), which is a primary accused in the Tirumala Tirupati Devasthanam (“TTD”) scam involving supply of adulterated Ghee.



Thus, it is submitted that the impugned article seeks to allege that plaintiff no. 1-company, has also indulged in the TTD scam, and that the plaintiff no. 1 company has ties with said Bhole Baba Oroganic Milk.

26. Attention of this Court has also been drawn to the newspaper report dated 11th November, 2025, published in the Economic Times, wherein, Bhole Baba Oroganic Milk has been imputed for setting up fake *Ghee* manufacturing unit, used to prepare Tirupati *Laddus*. However, it is submitted that the plaintiffs have no connection with the aforesaid Bhole Baba Oroganic Milk. It is submitted that the plaintiff has business dealings with another entity, namely Bhole Baba Milk Food Industries (Dholpur) Private Limited (“Bhole Baba Milk Food”), and that the same is an entirely different entity from Bhole Baba Oroganic Milk, which is the accused in the TTD scam.

27. In this regard, attention of this Court has been drawn to the table set out in the plaint, which brings forth the differences in both the companies. The same is reproduced as below:

28. Thus, learned Senior Counsel appearing for the plaintiffs submits that Bhole Baba Oroganic Milk and Bhole Baba Milk Food are distinct entities, and plaintiff no. 1-company has business ties with Bhole Baba Milk Food, and not Bhole Baba Oroganic Milk. In fact, plaintiff no. 1-company has never entered into any business dealings with Bhole Baba Oroganic Milk.

29. Learned Senior Counsel appearing for the plaintiffs submits that the TTD scam is being investigated by the Central Bureau of Investigation (“CBI”), led by a Special Investigation Team (“SIT”). The SIT had registered a First Information Report (“FIR”) against Bhole Baba Oroganic Milk and other accused persons, and two chargesheets have already been filed. Notably, neither the plaintiff no. 1-company, nor Bhole Baba Milk Food has been named in the FIR, or the chargesheets filed with regard to the TTD scam.


30. Thus, it is submitted that defendant nos. 1 to 4 have maliciously published the impugned article, making false and incorrect statements linking plaintiff no. 1 company with Bhole Baba Oroganic Milk, which is an accused in the TTD scam. These imputations have been made with a deliberate attempt to tarnish the reputation of plaintiff no. 1-company.

31. It is further submitted that the defendant no. 4 company has made identical motivated allegations against the plaintiffs on the ‘Sakshi TV’ news channel on 14th February, 2026. Further, the defendant no. 4 has also maliciously published the false narrative on the platform of defendant no. 8, i.e., YouTube, which has 2.5 billion monthly users. Thus, it is submitted that



dissemination of such false narratives on a platform with such an extensive viewership has caused grave harm to the plaintiffs.

32. It is submitted that the impugned reports have been published on all channels of 'Sakshi TV' and on the platform maintained by defendant no. 8. The screenshot in this regard, as filed along with the plaint, is reproduced as under:



33. Learned Senior Counsel appearing for the plaintiffs submits that the plaintiffs, immediately on 14th February, 2026, issued a legal notice to the defendant no. 1 indicating that Bhole Baba Organic Milk and Bhole Baba Milk Food are two distinct entities. The legal notice was also accompanied by a clarification issued by Bhole Baba Milk Food, stating that it has not been named in the TTD scam and has, in fact, never supplied *Ghee* in the southern parts of India.



34. Pursuant to the aforesaid legal notice and clarification, the defendant no. 1, on 15th February, 2026, published the clarification submitted by plaintiff no. 1-company on *Page 3* of the '*Sakshi Newspaper*'. However, no clarification was issued on any other platforms of the defendants. Further, the defendant no. 4 has neither published a clarificatory statement nor retracted the impugned statements. Thus, it is submitted that the publication of the clarificatory statement on the third page of the *Newspaper* is not sufficient to repair the damage/harm caused to the plaintiffs.

35. The present matter requires consideration.

36. Accordingly, issue notice to the defendants by all modes. Notice is accepted by learned counsel appearing for defendant no. 6.

37. Issue notice to the other defendants by all modes.

38. Let reply be filed within a period of four weeks.

39. Rejoinder thereto, if any, be filed within a period of two weeks, thereafter.

40. Considering the submissions made before this Court, a *prima facie* case been made out by the plaintiffs and irreparable harm shall be caused to the plaintiffs if interim relief is not granted in favour of the plaintiffs. Further, this Court is of the considered view that the balance of convenience also lies in favour of the plaintiffs.

41. Accordingly, the following directions are issued:

- i. The defendant nos. 1 to 4 and defendant no. 9 are restrained from posting, publishing, uploading, writing, speaking, distributing and/or republishing any false, misleading and defamatory content against the plaintiffs, on any web platform or in a physical newspaper, including, the platforms maintained by defendant nos. 6 to 8;



- ii. The defendant nos. 1 to 4 are directed to take down the impugned article and impugned reports, and any other publication containing identical as well as similar statements, maintained on their profiles on the platforms of defendant nos. 6 to 8;
- iii. The defendant nos. 1 to 3 are directed to take-down within 24 hours the impugned article dated 14th February, 2026, or any other related articles published by defendant nos. 1 to 3, on their platform- 'www.sakshi.com';
- iv. Defendant nos. 1 to 3 are directed to take-down, within 24 hours of this order, the impugned reports dated 14th February, 2026, or any other defamatory interview/ debate/ report published under the name of 'Sakshi TV', on various online platforms maintained by defendant nos. 6 to 8, the links of which, are given in **Annexure 1** of this order;
- v. In case, the aforesaid direction is not complied with by defendant nos. 1 to 3 within 24 hours of this present order, the defendant nos. 6 to 8 shall take down the impugned content, details of which, are given in **Annexure 1** of this order;
- vi. Defendant no. 4 is directed to remove, within 24 hours, the following links, viz. <https://www.youtube.com/watch?v=wAeFDSYwMT0> and <https://www.youtube.com/watch?v=FHce6zIK7mw>.
- vii. If the aforesaid direction is not complied with by defendant no. 4, the defendant no. 8 shall remove the aforesaid links from its platform.
- viii. Defendant no. 5 is directed to block and disable access to the URLs within 24 hours, details of which, have been given in **Annexure 1** of the present order; and
42. Compliance affidavit under Order XXXIX Rule 3, CPC be filed



within a week, from today.
