पुणे : राज्यातील भीमा आणि उल्हास या दोन मोठ्या आणि महत्त्वाच्या नद्यांतील वरडोव्घनामक माशांच्या पोटात सूक्ष्म प्लास्टिक आढळले आहे. उल्हास नदीतील माशांच्या तुलनेत भीम नदीतील प्लास्टिक प्रदूषण जास्त असल्याचे संकेत नव्या संशोधनातून मिळाले असून, नद्यांच्या प्रदूषणाचा गंभीर प्रश्न अथोरंखित झाला आहे.

मायक्रो-सीटी स्कॅनिंग' या अत्याधुनिक तंत्रज्ञानाचा वापर करून प्रथमच वडोळा माशाच्या जबड्याची आणि घशाची शारीरिक रचना अभ्यासण्यात आली. या माशाच्या जबड्यात अनेक बारीक, वळणदार दात असतात. त्याच्या घशातील रचना जलद गतीने भक्ष्य पकडण्यास अनुकूल असते. नद्यांच्या गढूळ पाण्यात ख्राद्य पकडताना आणि ते घळताना प्लास्टिकचे कण या दातांमधून अडकून पुढे पचनसंस्थेत ढकलले जातात, असे दिसून आले.

संशोधन केले. हा शोधनिबंध

उजनी धरणातील भिगवण आणि
दरजेत भागात उल्लास नदीतून गोळा
केलेल्या ३४ माशांच्या पचनसंस्थेतून

एकूण ४७ सूक्ष्म प्लास्टिकचे कण आढळले. संशोधनामध्ये तपासलेल्या एकूण वरडोळ्यात माशांपैकी ५२.९४ टक्के माशांच्या पोटात प्लास्टिकचे कण आढळून आले आहेत. विशेष म्हणजे उल्हास नदीतील ३५.७१ टक्के माशांच्या पोटात, तर भीमा नदीतील ६५ टक्के माशांच्या पोटात हे सूक्ष्म कण

आढळून आले. हे घटक मानवी टाकाऊ कचरा व दैनंदिन वापरातील प्लास्टिकच्या विघटनातून तयार झाल्याचे स्पष्ट होते. वरडोळा मासा नद्यांच्या तळाशी असणाऱ्या गाळात खाद्य शोधत असल्याने पाण्यातील तळाशी जमा झालेले प्लास्टिकचे कचरे त्यांच्या शरीरात शिरकाव करत असल्याचे संशोधनातून स्पष्ट झाले.
