This is with reference to our earlier submission dated November 6, 2025, regarding the outcome of the Board Meeting of Highway Infrastructure Limited held on the same day, wherein the Unaudited Financial Results (Standalone and Consolidated) of the Company for the quarter and half year ended September 30, 2025 along with the Limited Review Report, were submitted.

It has come to our notice that, due to an inadvertent error, half-yearly option was selected in drop down instead of quarterly in the XBRL filed on November 6, 2025. Upon identifying the same, we had filed the revised consolidated XBRL on November 26, 2025, and the acknowledgement for the same has been received via email a copy of which is enclosed herewith. However, the NEAPS platform didn't permit us to file the revised standalone XBRL due to which we were not able to file the same at that time.

Further, pursuant to receipt of your email dated January 6, 2026, we have now filed the revised XBRL on the path mentioned in your email.

We request you to kindly take the revised XBRL of the financial results on record and replace the earlier submission made on November 6, 2025.
