- Fire impacted mainly stock of raw materials and finished goods. While there were no serious damages to the plant & machinery and factory building. Our dedicated team is fully committed to carrying out a comprehensive evaluation of the situation, ensuring we can facilitate a swift and effective recovery.
- We want to assure our stakeholders that all assets of the Company are fully insured, and we have promptly informed our insurance provider about the incident.
- The Samsara Recycling Private Limited plant, located at Survey No. 64/1, Village Kukadsar, Kachchh, Gujarat, 370410, will remain temporarily closed while we work diligently on restoration efforts. In the meantime, we are actively engaging a third-party manufacturer to ensure that we continue to meet our customers' orders and maintain our service commitments.
