Pursuant to Regulation 29(2) read with regulation 29(3) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, as amended from time to time ("SAST Regulations"), please find enclosed the requisite disclosure in the prescribed format in respect of the Himatsingka Seide Limited ("Target Company" or "TC") by Abakkus Growth Fund through its schemes Abakkus Emerging Opportunities Fund – 1, Abakkus Diversified Alpha Fund, Abakkus Diversified Alpha Fund – 2 ("Seller"), by way of open market sale on BSE and NSE.

Abakkus Growth Fund, a SEBI registered Category III Alternative Investment Fund bearing registration no. IN/AIF3/18-19/0550. Abakkus Asset Manager Private Limited (Formerly Known as Abakkus Asset Manager LLP) is the Investment Manager to the Fund and its schemes named above.

The Seller had disclosed its acquisition of the Target Company as per Regulation 29(1) consequent to the said disposal, the aggregate shareholding of the Seller and persons acting in concert in the Target Company has decreased from 6.78% to 4.31% of the total paid-up / voting equity share capital of the Target Company, representing a change of 2.47% (being $\geq 2\%$) and thereby triggering the disclosure requirement under Regulation 29(2) of the SAST Regulations.

Please find attached disclosure under Regulation 29(2) of SEBI (SAST) Regulations 2011 by the Seller providing further clarification with respect to the disposal of shares of Target Company through Open Market route, to enable the stock exchange make requisite disclosure on its website.
