**Sub: Qualified institutions placement of equity shares of face value ₹5 each (the “Equity Shares”) by Himatsingka Seide Limited (the “Company”) under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”), and Sections 23(1)(b), 42 and 62(1)(c) of the Companies Act, 2013, as amended, including the rules made thereunder (the “Issue”).**

In furtherance to our earlier intimation dated October 24, 2024 and October 29, 2024, with respect to the Issue which opened on October 24, 2024 and closed on October 29, 2024, we wish to inform you that the Securities Committee of the Board of Directors (“Committee”) of the Company has today, i.e. October 30, 2024 approved the issue and allotment of 2,72,85,129 Equity Shares of face value of ₹ 5 each, to eligible QIBs at the issue price of ₹146.60 per Equity Share including a premium of ₹141.60 per Equity Share, (which includes a discount of 5% (i.e. ₹7.71 per Equity Share) to the floor price amounting to ₹ 154.31 per Equity Share, as determined in terms of SEBI ICDR Regulations), aggregating to ₹ 400 Crores (INR Four Hundred Crores Only), pursuant to the QIP.

Pursuant to the allotment of Equity Shares under the QIP, the paid-up equity share capital of the Company stands increased from ₹ 49.23 crores consisting of 9,84,57,160 Equity Shares of face value of ₹ 5 each to ₹ 62.87 crores consisting of 12,57,42,289 Equity Shares of face value of ₹ 5 each.

Further, we have enclosed herewith the list of allottees who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue, marked as **Annexure I**.
